INTRODUCTION

The annual Statements of Community District Needs (CD Needs Statements) and the Community Board Budget Requests (Budget Requests) are Charter requirements and an integral part of the City's budget process. When developed through informed planning and careful consideration, CD Needs Statements and Budget Requests can play an important role in consultations of community boards with agencies, elected officials and other key stakeholders on a broad range of local planning and budget priorities. These tools also provide a valuable public resource for neighborhood planning and research purposes, and are used by a wide audience seeking information about New York City's diverse communities.

This year, for the first time, community boards electronically submitted a CD Needs Statement combined with their Budget Requests. The goal of these improvements is to simplify preparation of both documents for the community boards and to make the information community boards provide more easily accessible for City agencies and other stakeholders. Simplified and more efficient processes will allow all parties involved in the budget process to consider budget decisions more thoroughly, with better results for all New Yorkers.

Many people have no regard for traffic rules and there is chaos when irrspsonable drivers, etc. speed and don't abide my traffic laws For our growing Communiities there is: 1) complete absence of any complete community center to serve the needs of Indo-Caribbean and South Asian children and families. 2) Lack of legal affordable housing options 3) Not enough youth and academic programs for children from ages 6-18 especially when the drop out rate at high sch total disregard for our children & residents safety.

Need for new street and sidewalks by Golf Parking and World War One Memorial area in Forest Park. New asphalt surface for Tennis Court on Paklane south At 90th St. In Woodhaven, Forest Park. New bicycle paved path from the Carousel parking lot to Myrtle Ave. in Forest Park. Rehabilitation of the Greenhouse Playground, upgrade equipment, swings, slides, and Safety surface. Plant Street Trees in District Particularly Jamaica Avenue from 121st Street to Dexter Court and along Woodhaven Blvd. from Myrtle Ave. to 101 Ave. Much of this area is devoid of Greenery. In an effort to beautify these strips we request planting of Calorie Pear trees along these areas. Purchase Equipment for Maintenance & Operation District 9- Our district is still in need of the following pieces of equipment: 2 crew-cabs pick-up Trucks with hydraulic tailgates; 1 mini sweeper for drives, parking lots, sidewalks and mall cleaning; 3 snow blowers, 3 weed trimmers, an 1800 series dump truck; 1 tractor driven giant vac-blower as well as 3-grass cutting yazoos and 1 grass cutting gravelly unit with blower attachment. Fund park Enforement patrol Unit for Forest Parkas the park has many athletic facilites and special events. It also has 543 acres of forest, which feature numerous hiking trails and a 4-mile equestrian path. Our park has a high volume of events and activities. Problems such as user conflicts permit violations, crowd control, vandalism, deviant behavior and other enforcement issues are in need of attention. Often, PEP units are not available to respond to Forest Park’s needs due to citywide distribution of their staff, and summer staffing of pools and beaches. This has created a rise in misuse of and vandalism to park facilities, damage to the landscape, criminal activity and mischief. Pruning Contract for Forest Park & CB9- This is now a safety issue. Branches have fallen during park concerts, storms and events. It is only a matter of time before someone is seriously injured or killed. The 543-acre park has large mature trees that are 150 years plus. We desperately need a PIP (Parks Inspection Project) funded along with pruning dollars. Increase Tree Stump Removal; Provide Contract for Street Trees and Increase Personnel Request contract removal of tree stumps, shafts and dead trees. Fund Maintenance Workers on a Full Time Basis- Maintenance workers are funded for eight months only. During the winter they are laid off. When they return they have a backlog of winter work i.e. painting, cement work, repairs etc., that can be done during the winter. Fund the entire project. Fund Maintenance Workers on a Full Time Basis- Maintenance workers are funded for eight months only. During the winter they are laid off. When they return they have a backlog of winter work,i.e. painting, cement work, repairs etc., that can be done during the winter. Fund the entire project.
