Community Board 11, located in Northeast Queens, is bounded by Nassau County on the east, Little Neck Bay and 26 Avenue on the north, Utopia Parkway, Fresh Meadows Lane and 210 Street on the west and the Grand Central Parkway and Horace Harding Expressway on the south. The District covers 9.6 square miles comprising the neighborhoods of Auburndale, Bayside, Douglaston, Hollis Hills, Little Neck and Oakland Gardens.

Neighborhoods in CB 11 are residential in zoning and character with the major portion of the district comprised of 1- 2- and 3-family owner-occupied houses and several, low-rise cooperative and condominium apartment complexes developed 60-70 years ago. About 30% of the housing stock is comprised of rental apartments. Douglas Manor and Douglaston Hill are landmarked communities. These areas were developed about 100 years ago.

The shopping needs of the residents are met by commercial strips on Francis Lewis Boulevard, Bell Boulevard, Springfield Boulevard, Northern Boulevard and along the Horace Harding Expressway. There is a shopping center anchored by Macy's, Toys-R-Us, Modell's and Fairway Market on Douglaston Parkway, and a small shopping plaza at Horace Harding Expressway and Little Neck Parkway.

The District is known for its approximately 800 acres of parkland. Alley Pond Park, which is a large, regional park, has areas under Federal and State tidal and fresh water wetland protection, as does Udall's Cove and Aurora Pond. Alley Pond Environmental Center (APEC) is located at the base of Little Neck Bay.

The shoreline in Bayside is part of the Greenway system and supports a marina for recreational boating and fishing and a bicycle and jogging path. Adjacent to this shoreline is Crocheron Park and

INTRODUCTION

The annual Statements of Community District Needs (CD Needs Statements) and the Community Board Budget Requests (Budget Requests) are Charter requirements and an integral part of the City's budget process. When developed through informed planning and careful consideration, CD Needs Statements and Budget Requests can play an important role in consultations of community boards with agencies, elected officials and other key stakeholders on a broad range of local planning and budget priorities. These tools also provide a valuable public resource for neighborhood planning and research purposes, and are used by a wide audience seeking information about New York City's diverse communities.

This year, for the first time, community boards electronically submitted a CD Needs Statement combined with their Budget Requests. The goal of these improvements is to simplify preparation of both documents for the community boards and to make the information community boards provide more easily accessible for City agencies and other stakeholders. Simplified and more efficient processes will allow all parties involved in the budget process to consider budget decisions more thoroughly, with better results for all New Yorkers.

2. OVERVIEW OF COMMUNITY DISTRICT

Queens Community Board 11 provided the following overview of their district:

The population estimate of Community Board 11 is now approximately 120,000 people, having a steady increase over the past 5 years. CB 11 is a thriving upper, middle income community with a median household income of about \$75,000. The District has a mixed white, non-Hispanic (42%) and a growing Asian (41%) population. Over the past 10 years, the Asian population has grown while the white population has decreased by about 10%. The population has a substantial elderly (over 65) population, (17 %). The school age population, ages 5-19, has been about 16% of our population over the past five years. There is an increase in the number of people who are in their child-bearing years. New homes continue to be built in the district along with the enlargement of existing homes to accommodate an increasing population of families attracted by the educational opportunities in the district. Elderly homeowners are selling their homes to relocate. Many of the new homes are much larger than the existing housing stock and reflects an increase in wealth in the district. In areas that are zoned for multiple families, homes are being renovated to reflect the zoning. There are also increased complaints about illegal occupancies. There are many new, larger commercial developments along the commercial overlay zones. Small commercial strips have been replaced by larger retail stores, offices and community facilities. The increase in the construction accommodates the growing Asian population and their needs. Hotels are being built in the district for the first time. Marriott will build two hotels because they see the need and convenience of Queens to the airports, Citifield, the USTA stadium, transportation to Manhattan while being more affordable than a hotel room in Manhattan. The number of health care facilities have increased throughout the district in new construction and in private house conversion. North Shore/LIJ Health System has opened satellite clinics and will open a Core Laboratory next year. Day care facilities have also increased with the need for care of young children since both parents work and the advent of Pre-K for all children in the City.

3. MAIN ISSUES

As part of this year's process, community boards were asked to select from a list the three most pressing issues facing their district. Queens Community Board 11 identified the following three issues:

- *Parks*
- *Quality of life issues and neighborhood preservation*
- *Street conditions*

Queens Community Board 11 provided the following explanation for their choices:

The goal of neighborhood preservation is to preserve the special qualities that have made lower density, suburban-style neighborhoods in northeast Queens attractive. There are also two landmarked districts in CB 11. As the City has grown, so have concerns about how much development is good. The Board supported rezoning to prevent out-of-character overdevelopment. However, there are still concerns with zoning and building violations and how the City responds to these complaints. Street conditions and transportation issues have become a growing problem. We have seen increased traffic and roadway complaints such as poor road conditions and potholes and need for pavement markings. The winters have caused a great deal of damage to the roads. Four highways intersect through the district adding to the various needs. There has also been increased demands for speed bumps and other traffic calming devices as traffic has increased. CB 11 residents love their parks and trees. This district has several large parks and tree-lined streets. Street and park tree maintenance, renovation of ball fields and park improvements are important to the residents of CB 11. They add to the attractiveness of the neighborhoods and the quality of life the residents enjoy. The preservation of the wetland areas and protection from development is of paramount importance in the north end of the district which borders Little Neck Bay.

4.1. Health Care and Human Services Needs and Requests

Main Issue

Programs, services or facilities for seniors

The Community Board provided the following explanation for the above issue:

CB 11 has had only one full service DFTA funded senior center, the Bayside Senior Center. We advocated for more senior services and fortunately, the Samuel Field Y received funding for a center at their Little Neck facility. They also operate a NORC. Services Now for Adult Persons also received funding from DFTA to provide casework management for all of CB 11. This has been great help to our seniors. We are also working with the local councilman and the NY Academy of Medicine with DFTA to ensure that the district is age-friendly. Transportation for seniors for health visits and shopping is sorely lacking in the district.

Our senior population has been consistently about 17% of our total population, one of the highest senior populations in NYC. We had only one DFTA funded senior center, Bayside Senior Center, located in the district. We have advocated for increased services and DFTA did provide additional funding for the Samuel Field Y to run a full service center in the eastern section of the district. We still advocate for more senior services in the western part of the district, Auburndale area.

4.2. Youth, Education and Child Welfare Needs and Requests

Main Issue

Capacity of educational facilities

The Community Board provided the following explanation for the above issue:

We have three high schools within CB 11, Cardozo, Bayside and Francis Lewis. All of them are at 150% of capacity. CB11 schools are all within School District 26. Some of the elementary and middle schools are overcrowded and others are underutilized. In most elementary schools class sizes are 30-34 students where classes should have no more than 25 students. D.26 schools are prized in Queens and many families move here for the quality of the education.

Community District Needs and Requests

4.2.1. Community District Needs and Requests Related to Educational Facilities and Programs

The Community Board provided the following high level comments and background on the District's needs:

There are two issues regarding schools in CB 11 which are all within the boundaries for D.26. One is the overcrowding of the high schools, Cardozo, Francis Lewis and Bayside. The board has asked for relief from the overcrowding of the schools. As long as parents seek to send their children to these high performing schools and the Board of Education admits them, then there will be overcrowding. The SCA is in the process of acquiring property for a new high school bulidng. We are working with the Council Member, the D26 administration, and the UFT to discuss options for the use of the school. The second need in the district is for a specialized high school school in order to keep our high performing students from having to travel out of the borough. Queens has the least number of seats for specialized programs. Upwards of 75% of students from some of our middle schools are accepted at specialized schools such as Stuyvesant, Bronx Science and Brooklyn Tech.

4.4.1. Community District Needs and Requests Related to Water, Sewers and Environmental Protection

The Community Board provided the following high level comments and background on the District's needs:

Within the past few years, DEP installed a CSO facility at the base of Little Neck Bay to capture storm water before it enters the bay. The board has worked with the NYSDEC and the Dept. of Parks to preserve the area's wetlands and improve the quality of water in the bay. The CSO project also stopped flooding the Bayside Hills section with the installation of catch basins. There are some other areas of flooding in the district due to the malfunctioning seepage basins. There is also concern that more intensive storms could flood areas around the bay. The repair of our DEP infrastructure is important to maintain our streets and water services.

4.5. Land Use, Housing and Economic Development Needs and Requests

Main Issue

Zoning review and enforcement, and code enforcement

The Community Board provided the following explanation for the above issue:

Rezoning started in our Bayside community and since 2004, all of the district was rezoned to reflect more accurately the development in the various neighborhoods. Ensuring zoning compliance and code enforcement has been a great concern to our residents. There has been a great deal of home construction and an increase in illegal conversions and illegal uses of property. There is a concern with the loss of green space with the increase in development.

Community District Needs and Requests

4.5.1. Community District Needs and Requests Related to Land Use

The Community Board provided the following high level comments and background on the District's needs:

The Department of City Planning (DCP) rezoned 350 blocks of Bayside in 2004, 135 blocks of Douglaston and Little Neck in 2006, 50 blocks of North Flushing/Auburndale in 2009 and 418 blocks of Auburndale, Hollis Hills and Oakland Gardens in 2010. The goal of rezoning was to curtail overdevelopment and maintain the low density nature of the district. New zoning designations were also introduced for single family homes, R2A and R1-2A, to limit the size of homes. Ensuring compliance is important to residents to maintain the suburban-like feel of the neighborhoods in CB 11. There has been an increase in complaints to the Dept. of Buildings for illegal commercial use in a residential zone and illegal conversions. Residents are still frustrated by the perceived inability of the Buildings Department to stop illegal construction, violation of zoning laws and illegal occupancy. DOB must continue to be funded to maintain an adequate number of plan examiners and inspectors. Many times, inspectors do not obtain access to the premises they must inspect. Access warrants are difficult to obtain in the courts, and the complainants feel that nothing is being done to stop illegal conditions. Unfortunately, in many cases this may be true, but balancing private property rights with government enforcement continues to be a dilemma.

4.5.3. Community District Needs and Requests Related to Economic Development

The Community Board provided the following high level comments and background on the District's needs:

The district has several thriving commercial strips along its main avenues. Bell Boulevard, between Northern Boulevard and 35 Avenue, is a Business Improvement District (BID). The BID helps fund improvements along the Bell Boulevard commercial strip. The Economic Development Corporation, working with the BID, has plans for a streetscape project on Bell Boulevard. The BID also sponsors events to attract new businesses and shoppers to the boulevard. This strip is known for the diversity of ethnic restaurants and nightlife in its various bars and restaurants. A concern of the residents is the continued closure of small businesses on Bell Boulevard being replaced by only bars and restaurants. The scarcity of parking spaces is also an issue that has been raised since it is necessary to attract customers. The BID, with the help of Councilman Vallone, conducted a parking study to determine how to improve the situation. A parking structure may be the only solution. Adjacent to the Douglaston LIRR Station, on the north side of the tracks, many businesses closed. The Douglaston Local Development Corporation, formed by local residents, is working to revitalize the area. This year, the LDC applied for and was approved for a DOT Public Plaza on the north side of the LIRR station. It is hoped that the plaza can attract people to stay in the area and create businesses. Along Northern Boulevard, several new commercial retail stores are being developed. While many of the stores have been leased, there seems to be a lot of turnover and many stores remain vacant. In the meantime, businesses are also closing in the older storefronts along these commercial strips. Two hotels are under construction on Horace Harding Expressway and Utopia Parkway. This is a major change in the neighborhood. In Little Neck, in the one M1-1 district in the board, a new business, a watch assembly plant, has taken over an old business that moved and another new building will be constructed to house a North Shore/LIJ Health Systems Laboratory.

Roadway maintenance

The Community Board provided the following explanation for the above issue:

Roadway maintenance has become more of an issue in the district. With severe winters has come the deterioration of our roads which includes four major highways, the Long Island Expressway, Clearview Expressway, Cross Island Parkway and Grand Central Parkway and their service roads and feeder roads. The Comptroller sited the huge number of claims paid for pothole damage this past year.

Community District Needs and Requests

4.6.1. Community District Needs and Requests Related to Traffic and Transportation Infrastructure

The Community Board provided the following high level comments and background on the District's needs:

Roads have deteriorated over the winter months and our roads are very busy. Traffic has increased as the population has increased and more people have vehicles. Four major expressways and service roads intersect CB 11, the Long Island Expressway, Grand Central Parkway, Clearview Expressway and Cross Island Expressway. Resurfacing and maintenance of roads is a priority to the Board. Comptroller Stringer ClaimStat Alert cited the Grand Central Pkwy. and the Long Island Expressway as the thoroughfares generating some of the highest number of pothole claims. This district has one of the highest rates of car ownership. There is no mass transit except for buses. The NYCT, at the request of elected officials and with funding from Sen. Avella conducted a study of bus transportation and rider needs in Northeast Queens.

The Community Board provided the following explanation for the above issue:

This district has 3 large parks and the streets are lined with street trees. The maintenance and care of the trees has been a major concern of our residents especially following property and personal damage from storms in recent years. The State Senator has held hearings about tree maintenance because of the great concern. Comptroller Stringer, in his report "Compstat", cited the Parks Dept. claims as one of the highest and the longer a tree pruning cycle is, the higher the number of claims.

Community District Needs and Requests

4.7.1. Community District Needs and Requests Related to Parks and Recreational Facilities and Programming

The Community Board provided the following high level comments and background on the District's needs:

Parks and trees are the gems of this district. There are approximately 900 acres of parkland in CB 11. There are three large parks, three smaller park areas, lakes, a golf course, a golf driving range, a marina, many greenstreets and streets that are lined with trees. CB 11 is on the northshore of Queens overlooking Little Neck Bay and has extensive wetlands. Alley Pond Environmental Center sits on parkland at the edge of the wetlands. Conservation and preservation of our green spaces is a high priority in CB 11. This year, NYS DEC named CB11 a Tree-Friendly district.
