7:35pm PUBLIC HEARING RE: CITYWIDE OPEN RESTAURANTS ZONING TEXT AMENDMENT (ULURP #: 2021Y0291) – Presentation by Joy Chen, Queens Planner, NYC Dept. of City Planning

According to the Dept. of City Planning, New York City's Open Restaurants Program has re-energized city sidewalks and streets, has saved many small businesses, and saved thousands of local jobs. The City Council has passed legislation making this popular program permanent. The Dept. of City Planning has worked with the NY City Dept. of Transportation & other city agencies to draft regulatory changes that would allow sidewalk restaurants and cafes to remain in operation.

The Open Restaurants Text Amendment, according to this Application, will remove Article 1, Chapter 4 and all other text related to sidewalk café regulations from the Zoning Resolution. The proposed text amendment will no longer require restaurants to have appropriate zoning in order to apply for the sidewalk café program. If this text amendment is adopted, restaurants seeking to open a sidewalk café would be required to apply for approvals from the proposed DOT Open Restaurants Program.
