

## The Worker Cooperative **Business Development Initiative (WCBDI)**

In partnership with the NYC Council and the Office of the Mayor, New York City agencies are working to build a more vibrant and inclusive city. The NYC Department of Small Business Services (SBS) contributes to this vision by connecting New Yorkers to good jobs, creating stronger businesses, and building thriving neighborhoods across the five boroughs.



Fiscal Year 2016 | Working Together: A Report on the Second Year of the Worker **Cooperative Business Development Initiative** (WCBDI).

Worker cooperatives - businesses owned and operated by the workers - provide meaningful employment and help improve the City's economy. They allow New Yorkers to build businesses together, therefore allowing all the workers to gain access to upward mobility and better working conditions.

Through WCBDI, SBS helps New Yorkers start a worker cooperative or convert an existing business into one. This is the third annual report in the "Working Together" series, highlighting the achievements of WCBDI. Over the program's threeyear history, the City Council's support has grown from \$1.2 million to \$2.2 million, and the number of partner organizations has grown from 11 to 13\*.

In FY2017, SBS continued to support WCBDI by delivering business education services to the partners and the worker cooperatives they

serve. Partners convened throughout the year to share their successes as a group and to learn more about services provided by SBS, including Women Entrepreneurs NYC (WE NYC), courses and one-on-one assistance provided at the NYC Business Solutions Centers, and a tailored course for New Yorkers interested in growing by selling to government. Additionally, SBS highlighted our services at an assortment of panels, workshops, and/or educational events hosted by WCBDI partners and other worker cooperative support organizations.

A detailed list of the worker cooperatives assisted by WCBDI in FY2017 appears in the Appendix. At SBS, we look forward to continuing to help worker cooperatives become thriving businesses in New York City.

<sup>\*</sup> A total of 13 partner organizations received funding through WCBDI in FY2017. The Community and Economic Development Clinic at the City University of New York (CUNY) Law School received \$35,000. However, this organization was not managed by SBS, and therefore details of their work will not be included in this report.

# Measuring Our Success

The WCBDI developed four metrics on worker cooperative development against which to measure success in FY2017: worker cooperatives created, services provided to businesses and/or community-based organizations, education services provided, and total hires. The cumulative outcomes listed below were reported by WCBDI partners and are intended to summarize the activities conducted in the third year of the Initiative.

# WCBDI FY2017 Accomplishments

WORKER COOPERATIVES CREATED
(HARD LAUNCH AND/OR SOFT LAUNCH)

A worker cooperative is a business that is run and operated by the people who work in them, called worker-members. Available profits are distributed to worker-members, who make governance decisions democratically on a one-member, one-vote basis. WCBDI incubates worker cooperatives through specialized trainings and one-on-one services. WCBDI also helps traditional businesses convert to worker cooperatives. Creating a cooperative is a resource and time intensive process, requiring WCBDI partners to work closely with potential worker-members over a period that may span months or continue more than a full year.

WCBDI partners helped 18 new worker cooperatives hard launch by helping them acquire a federal tax ID, formation documents, appropriate licenses and permits, and register as a New York State sales tax vendor when applicable.

Additionally, WCBDI helped the remaining 18 worker cooperatives soft launch. These worker cooperatives were on the path to launch and had a predetermined industry and a set of committed workerowners, but they did not acquire the documentation as listed above for hard launches.





#### COMMUNITY-BASED ORGANIZATIONS

WCBDI provides one-on-one, specialized services focused on worker cooperative development that cover the following topics: bookkeeping, business launch, business plan development, financial planning, governance and internal manuals, legal issues, marketing and market research, strategic planning, succession planning, and translation. These services are provided to worker cooperatives and businesses interested in converting into worker cooperatives.

Additionally, WCBDI partners help community-based organizations in New York City that provide separate worker cooperative development to the communities they serve. As a result, WCBDI helps strengthen New York City's worker cooperative ecosystem.







#### **EDUCATION SERVICES PROVIDED**

WCBDI hosts workshops, intensive academies, and networking events for cooperative members and prospective cooperative members.

This metric represents the number of individuals who engaged in a series of curriculum-based workshops, conferences, lectures, and group trainings hosted by WCBDI in FY2017.



**TOTAL HIRES** 

A worker-member is a person who owns a share of the worker cooperative, is a beneficiary of a trust, or is a person who controls the cooperative with other worker-members. A non-member worker is anyone who is not a worker-member and who works for a worker cooperative. WCBDI provides capacity-building services to worker cooperatives, helping them increase their ability to take on new worker-members and/or non-member workers.

This metric represents the total number of jobs created in FY2017 and reflects employment of worker-members and non-member workers.


#### **New York City Network** of Worker Cooperatives (NYCNOWC)

# Worker Cooperatives Created

Worker cooperatives that were soft launched in this fiscal year will require additional time in the following fiscal year to hard launch. WCBDI creates worker cooperatives through academies, incubation, and conversion. This section of the report highlights some success stories for the Worker Cooperatives that were created.

#### Staten Island Cleaning LLC

Staten Island Cleaning LLC (Staten Island Cleaning) offers residential and commercial eco-friendly cleaning services. Staten Island Cleaning was incubated by the Center for Family Life (CFL) in partnership with La Colmena, a community job center in Staten Island. The members of Staten Island Cleaning were the first to participate in CFL's new incubation model, and chose the most intensive program pathway in order to launch their business within six months. The incubation model offered the members of Staten Island Cleaning an opportunity to create a national cooperative cleaning brand by being the first business within the brand family. Staten Island Cleaning members participated in an advisory council for the development of the national brand strategy.

With limited business experience, resources, and support networks, the members of Staten Island Cleaning, like many individuals organizing worker cooperative businesses, faced challenges and needed support to build these capacities. After the incubation process, the worker-members of Staten Island Cleaning demonstrated success in areas including business development — having launched their business through a sixmonth intensive program, marketing — having secured ongoing residential and commercial cleaning jobs within their first

month of business, and cooperation and innovation — having taken on advisory and leadership roles.

Staten Island Cleaning also joined Up & Go, a new web application for marketing and booking home cleaning services from worker-owned businesses. Up & Go was created by CFL with support from the Robin Hood Foundation. Staten Island Cleaning was able to accept cleaning jobs through Up & Go a month before their official business launch, and as a result, earned approximately \$2,000 in revenue and secured repeat customers. Staten Island Cleaning members took an active role in financial analysis and strategic planning of the Up & Go app.

Black Women Artists LLC (BWA) is a worker cooperative comprised of artists who create and present artwork that speak out against racial and gender-based discrimination. Prior to becoming a worker cooperative, BWA was already a business but was interested in converting into a worker cooperative. With the help of the ICA Group, BWA converted into a worker cooperative by formalizing their internal organizational structure.

Before converting into a worker cooperative, BWA was already working for various recognized museums and studios. However, as demand for their business grew, converting into a worker cooperative helped create an organizational structure that would allow the members of BWA to better handle their operational needs.

Woke Foods is a worker cooperative that that taps into the healing traditions of plant-based Dominican food to create recipes, host cooking classes, offer meal planning, and cater events. Woke Foods was launched through the Green Worker Cooperatives' (GWC) "Co-op Academy," which is an intensive, fivemonth long program that trains, coaches, and provides one-on-one services to prospective entrepreneurs looking to launch worker cooperatives.

GWC connected Woke Foods to community partners to help them get a vehicle for their business, apply for a business loan, gain access to a commercial kitchen, and receive a grant to do free cooking demonstrations for community members in the South Bronx.



# One-on-One Services Provided

WCBDI provides specialized one-on-one services to business entities and community-based organizations (CBOs), increasing the impact of the city's worker cooperative ecosystem.

These one-on-one services all focus on worker cooperative development. In FY2017, WCBDI provided 1769 one-on-one services to 180 unique entities. This section of the report highlights some success stories for one-on-one services provided.

# Beyond Care Childcare Cooperative

Beyond Care Childcare Cooperative (Beyond Care) was incubated by Center for Family Life (CFL) in 2008. After being in business for almost 10 years, Beyond Care was looking to open a new line of business in order to have another source of revenue. As a result, Beyond Care and CFL approached the Business Outreach Center Network (BOC) with a request for an industry analysis comparing the feasibility of starting a commercial day care versus starting a play space. The analysis contained information about regulations for both industries, extensive market research on the local area, and detailed financial projections for each line of business.

#### 1769 ONE-ON-ONE SERVICES PROVIDED

The one-on-one services provided by WCBDI cover a range of topics related to worker cooperative development. "Business Plan Development" was the most provided one-on-one service in FY2017, followed by "Strategic Planning," "Coaching," and "Internal Manuals."

A majority of the businesses and CBOs served receive one or more one-on-one services from WCBDI.

# Urban Justice Center's Legal Services

The worker-members of BKLN Clean, a woman-run cleaning products manufacturing and distribution worker cooperative, met through being involved with another longstanding worker cooperative in Brooklyn called Si Se Puede Cleaning Cooperative. After a years-long process of community organizing, and with the help of The Working World (TWW), the nine worker-members of BKLN Clean signed a cooperative operating agreement and incorporated their business with the State of New York.

TWW provided numerous one-on-one services to this new cooperative business, supporting the women to hone their cooperative governance and decision-making skills. TWW helped facilitate a break-even analysis and a market study in which all of the worker-members were involved in mapping and understanding their client base and competitive landscape. Finally, TWW facilitated a visioning process to see how this business could scale after a successful pilot year.

The Community Development Project at the Urban Justice Center (UJC) is a WCBDI partner organization that provides legal consultation for worker cooperatives. UJC provides legal, participatory research, and policy support to strengthen the work of grassroots and community-based groups in New York City to dismantle racial, economic, and social oppression. UJC lawyers take a client-centered, community lawyering approach to their work, where the lawyers prioritize informed decision-making among

their clients. In FY2017, UJC lawyers partnered with worker cooperative developers to ensure that worker cooperative members understood legal concepts that are important to the development of worker cooperatives. UJC helped worker cooperative members assess the pros and cons of each decision point so that members could fully participate in building and running their business.

# **Education Services Provided**



WCBDI offers workshops and events open to the public as well as intensive trainings specifically meant for prospective and/or current worker cooperatives. Education services provided by WCBDI can be standalone workshops for anyone to attend, or a curriculum-based series of trainings that require an application.

# The Working World's Worker Owned Rockaway Cooperatives Program

The Working World (TWW) is a WCBDI partner organization that offers financing, technical assistance, and educational services to worker cooperatives. In particular, TWW offers a five-week cooperative business training program in Far Rockaway, Queens, as part of their Worker Owned Rockaways Cooperatives (WORCs) program. In total, WORCs has helped more than 60 Rockaway residents learn about the worker cooperative business model, and three worker cooperatives have launched. TWW also added local capacity to the program by hiring two community members and graduates of the WORCs program to coordinate the program and provide onthe-ground assistance to its cooperatives. Worker cooperatives that were launched from WORCs have the added advantage of returning to TWW for financing assistance. Luv Custom Prints, a screen-printing and apparel worker cooperative, launched through WORCS, and received help from TWW to secure large contracts with Park Slope Food Co-op and the New York City Network of Worker Cooperatives. TWW approved a \$6,000 loan that allowed the company to purchase raw materials in bulk and respond to these orders. These large contracts created new visibility for the company, where local demand for their services grew substantially.

Application- & Curriculum-Based Courses The Center for Family Life (CFL), a WCBDI partner organization, has helped worker cooperatives since 2006. In total, CFL has incubated 15 worker cooperatives that were still operating in FY2017. After building up a significant amount of experience in incubating worker cooperatives, CFL decided to launch an educational training program for staff members from other community-based organizations (CBOs), teaching them how to incubate

worker cooperatives within their own organizations.

In FY2017, CFL hosted a total of 11 sessions for 27 CBOs. Session topics covered cooperative development, the solidarity economy, how to assess the need for cooperatives, cooperative principles and values, steps to starting a worker cooperative, and incubation models inspired by CFL's social group work methodology.

Application- & Curriculum-Based Courses The New York City Network of Worker Cooperatives (NYCNOWC) is a WCBDI partner organization and is the trade association for worker cooperatives in the New York City metropolitan region. NYCNOWC provides one-on-one services for worker cooperatives and helps them find clients and vendors within the cooperative ecosystem. Additionally, NYCNOWC hosts an annual worker cooperative conference, which includes panels, group sessions, and networking events. In FY2017, NYCNOWC introduced a new educational service for workermembers, called the Worker-member Leadership Council.

The Worker-member Leadership Council gives worker-members access to decision-making and advocacy opportunities within the city's worker cooperative network. NYCNOWC asked interested worker-members to submit an application, and selected five individuals. The first Leadership Council cohort worker-members were from Trusty Amigos Dog Walking and Pet Care Cooperative, ACTION Health and Safety, Bikes & Humans, Skedaddle Pest Management, and Ecomundo Cleaning.

Managing Director BronXchange The Bronx Cooperative Development Initiative (BCDI), a WCBDI partner organization, launched BronXchange, an online platform that connects Bronx institutions and nonprofits to high-road local vendors so they can do business. Local purchasing increases investment in surrounding neighborhoods and allows Bronx-based businesses to buy and hire locally. In order to launch BronXchange, BCDI conducted a series of workshops and events with local institutions informing them of opportunities to purchase from local businesses, paying close attention to Bronx-based worker cooperatives. Additionally, BCDI conducted educational sessions for worker cooperatives informing them of local contracting opportunities. On the BronXchange online platform, buyers and sellers can access a sortable database of local businesses and a suite of e-commerce services and financing tools to ease the purchasing process.

CFL incubated Love and Learn Child Care Cooperative in partnership with a community job center called La Colmena in FY2016. The first worker cooperative in Staten Island, Love and Learn provides child care services to families not only in Staten Island, but also in Manhattan and Brooklyn. CFL conducted extensive educational training programs in Staten Island on the definition of worker cooperatives and the benefits and challenges involved in starting one. The cooperative members of Love and Learn worked together with CFL to start this business from scratch. CFL also collaborated with Cornell University to provide nanny training to the cooperative members. UJC, a WCBDI partner organization, provided legal assistance to Love and Learn.

Since its founding, Love and Learn has become a member of NYCNOWC, the trade association for worker cooperatives. The members of Love and Learn have acquired jobs with various community-based organizations across the city, and engaged city officials, foundations, and the press on the trajectory of their business. The capacity-building services provided by CFL, allowed Love and Learn to add 10 cooperative members to their business in FY2017.

New Deal Home Improvement Company (New Deal) is a converted worker cooperative focusing on construction. Prior to being converted, New Deal sought assistance from GWC and ICA, and attended ICA's "Entity Choice and Tax Liability for Co-ops" workshop. They received valuable information on the tax liabilities faced by worker cooperatives, which allowed them to successfully navigate an often confusing area for small businesses, and particularly difficult for worker cooperatives.

Experienced construction professionals formed New Deal Home Improvement to build a business, try to push the home improvement industry to more "high road" employment practices, and serve as a means of training and integrating younger workers into this industry. ICA helped the cooperative design its administrative, client service, finance, and budgeting operations so that their operations would be transparent to all members and ensure that the business continued to be profitable.

New Deal then attended and completed GWC's five-month Co-op Academy, where members developed a new business model for the cooperative, interviewed almost 100 potential customers, learned communication and conflict management skills, and created accountability structures for the co-op. With the help of ICA and GWC, New Deal converted 11 employees into cooperative members.


WCBDI helps entrepreneurs obtain business ownership and/or employment in newly created, converted, and/or existing worker cooperatives.

In **converted worker cooperatives**, the hires were either previously employees or owners of the businesses, but now are all cooperative members. In FY2017, 58 individuals became cooperative members of converted worker cooperatives.


