Executive Summary

The NYC Taxi and Limousine Commission (TLC) is committed to improving the quality of accessible services in the for-hire (FHV) industry. Since the adoption and implementation of TLC rules governing wheelchair accessibility in January 2019, there has been dramatic improvement in service, even with the significant impacts to the industry due to the Covid-19 pandemic.

This report evaluates accessible service and performance of both the FHV Trip Mandate and FHV Central Dispatch Exception Accessibility Programs for Year 3 (October 2020-June 2021)* and Year 4 (July 2021-June 2022). In Year 3 and Year 4, 2% of bases chose to provide accessible service under the Trip Mandate option, whereas 98% of bases chose to contract with an approved accessible vehicle dispatcher to meet their accessible service requirement under the Central Dispatch Exception program. The share of bases participating in the respective programs is consistent with Year 1 and Year 2.


The TLC also acknowledges that more work must be done to ensure that all customers who use wheelchairs receive safe and reliable service from all FHV bases. To improve service and accountability, TLC will continue to partner with groups and other entities, ensure training is conducted with bases, and increase awareness of the wheelchair accessible vehicle (WAV) options available. Taking these steps will lead to greater universal compliance from all FHV bases regardless of the option they choose.

^{*}The pandemic also effected Year 2 compliance reporting period. To provide bases and dispatchers more time to comply with TLC's adopted rules for accessible FHVs, the reporting period in Year 2 was extend by 3 months for a total of 15 months, July 2019-September 2020.

COVID-19 Impacts


All TLC-licensed industries, including the for-hire vehicle sector were affected by the Covid-19 pandemic and its unprecedented global reach. As is the case with most industries, the effects of the pandemic contributed to decreased ridership and fewer cars on the road.

The pandemic was most acute in April 2020 when the lowest monthly completed trip count was recorded at 1,122 trips. However, trips started to slowly recover in October 2020 and hovered around pre-pandemic program standards in March 2021.



Fleet Information

FHV WAVs on the Road



At the end of this reporting period in June 2022, there were 3,457 FHV WAVs on the road, which is more than twice the number of FHV WAVs operating at the end of the previous reporting period of September 2020. These vehicles have completed over 700,000 trips since the implementation of the FHV accessibility rules in January 2019.



All FHV bases licensed by the TLC are required to provide service to wheelchair-using passengers. As of January 14, 2019, TLC rules require each FHV base to either dispatch a minimum percentage of its annual trips, increasing each year, to wheelchair accessible vehicles (WAVs) or contract with an approved Accessible Vehicle Dispatcher to service WAV trips.

FHV WAV service requirement can be fulfilled in one of two ways:

Option #1: Trip Mandate

- Bases that choose this option must service a percentage of trips using wheelchair accessible vehicles.
- Any trip dispatched to a WAV counts toward meeting the trip mandate. The passenger does not have to specifically request a WAV.

Option #2: Central Dispatch Exception (FHV WAV)

 Bases may choose to contract with an approved Accessible Vehicle Dispatcher to service WAV trips rather than servicing the trips themselves. Bases are responsible for entering into a contract with the approved dispatcher. The dispatcher is responsible for providing trips under specific wait time standards.

Rule Requirements: Trip Mandate

The compliance report evaluates the following periods:

- Year 3: October 1, 2020 to June 30, 2021
- Year 4: July 1, 2021 to June 30, 2022

As a result of the unprecedented effects of the pandemic, the FHV compliance evaluation period for Year 2 was extended by 3 months providing a 15-month evaluation period between July 2019 to September 2020. Therefore the Year 3 reporting period starts in October 2020.

Requiring bases to dispatch trips to WAVs increases the overall number of FHV WAVs in circulation. It also seeks to increase the number of WAVs operating at any given time, reducing wait times for passengers requesting the service.

Rule Requirements: Central Dispatch Exception

The evaluation period for this compliance report is:

- Year 3: October 1, 2020 to June 30, 2021
- Year 4: July 1, 2021 to June 30, 2022

Bases that affiliate with an approved Accessible Vehicle Dispatcher are subject to wait time requirements. The goal of this option measures timeliness and efficiency of service, in a short amount of time, regardless of customer's pickup location.

- In year 3, only 32 or 14% of bases met the trip mandate requirement.
- In year 4, 10 more bases met the trip mandate requirement for a total of 42 bases.
- Despite an increase in utilization, compliance with the Trip Mandate Rule remained low during this reporting period. See Appendix A for a complete list of bases.


- Between the end of Year 3 (June 2021) and the end of Year 4 (June 2022), the number of WAV trips almost doubled, and even exceeded pre-pandemic levels reported in Year 2.
- However, the total percent of trips serviced by a WAV was 10% or less of the total share of trips for both Year 3 and Year 4, demonstrating the need for significant improvement.



Central Dispatch Exception Performance

Central Dispatch Exception: Trips Completed


Percent of Trips Completed Under Required Times for All Dispatchers



- During Year 3 the approved accessible vehicle dispatchers were required to provide 80% of trips in 15 minutes or less.
- Starting in Year 4 (July 2021) requirements increased, and dispatchers were required to provide 90% of trips in 15 minutes or less and 80% of trips in 10 minutes or less.
- Dispatchers were unable to consistently provide trips in 10 minutes or less but there is greater consistency amongst all dispatchers providing trips within 15 minutes or less starting in January 2022 which is indicative of service recovery after Covid.

Central Dispatch Exception: 15 Minute Wait Time


Percent of Trips Completed Under 15 Minutes for All Dispatchers



- The chart reflects how each approved accessible vehicle dispatcher was impacted by the Covid-19
 pandemic and recovery phase.
- Lyft continued to struggle in Year 3 to reach the minimum requirements for the 15-minute timeframe. However, there were positive shifts in July 2021 in which Lyft began to consistently meet and/or exceed TLC's requirement.
- Uber met the minimum requirements for the 15-minute category in all reported months.

Central Dispatch Exception: 10 Minute Wait Time

- Both Uber and Lyft showed signs of recovery and met the wait requirement in January 2021. However, both companies were unable to meet the requirement consistently.
- After July 2021, Uber reflected greater levels of consistency, growth, and compliance as it climbed to meet the minimum wait time requirements governing the rules of the Central Dispatch Exception.



TLC will continue to monitor compliance with its accessibility rules and work to increase visibility of the various options of accessible service that riders can access.

We will also continue to foster partnerships with disability advocates, FHV bases, and the Mayor's Office for People with Disabilities (MOPD) in conjunction with TLC's Office of Inclusion to make sure passengers are aware that they have a right to equivalent FHV service.

TLC will work to improve accessibility in the FHV sector in the following ways:

Trip Mandate Rule

- Engage and re-train FHV bases that are not in compliance with the Trip Mandate Rule.
- Give bases opportunity to improve compliance or choose Central Dispatch Exception before issuing enforcement action.

Central Dispatch Exception

- Assess and revise evaluation period to monitor compliance throughout the year.
- Require central dispatchers to develop and present to TLC a plan to meet minimum wait time requirements consistently
- Promote passenger awareness of the availability of WAV options by affiliated bases.
