## **ANNUAL REPORT FOR 2010**

The Veteran's Advisory Board (VAB) was chartered in 1987 under Local Law 53 to advise the Mayor's Office of Veterans' Affairs on all matters concerning Veterans.

Legislation expanding the VAB from five to nine members under Local Law 45 was implemented in 2002. There are nine appointees; five appointed by the Mayor and four appointed by the City Council. Each Borough of the City of New York is represented on the Board.

In 2006, intro 233 enhanced the structure of the VAB and added annual reporting requirements. Under this expanded enhanced Board, the first Chairman of the VAB was elected by the Board in 2008 and resigned his position in February 2009.

At the September 2009 Board meeting, Manhattan Representative Vincent McGowan was voted as the Chairman and Staten Island Representative Lee Covino as the Vice-Chairman.

The Board drafted By-Laws and adopted them in December 2009.
