#### Subject Details

Advocating for the refining and continued implementation of an area -wide Plan with Current period focus on "kick-starting" Webster Avenue Redevelopment, completing Fordham Road Reconstruction Project, Rezoning Fordham Road and comment on the redesign, reconfiguration and reconstruction of Fordham Plaza.

Obtain support and continue collaboration of New York City, it's agencies, departments, commissions and public authorities/corporations -- including the Mayor's Office, the various Deputy Mayors, Transportation, Parks, City Planning Departments, DDC, EDC, HPD, SBS, Local Community Boards and the MTA -- for approvals and funding to advance and implement an ambitious multi-dimensional and multi-phase urban redesign and redevelopment plan for the research, educational and cultural institutions natural district of the north central Bronx, located around The Bronx River, Bronx Park and the Mosholu. The major focus during this reporting period was to advance the implementation and conversation with respect on how to trigger and advance redevelopment opportunities along Webster Avenue, now that the mixed use re-zoning has been approved. The discussion focused on potential redevelopment strategies and mechanisms that might be employed to advance and jumpstart this effort, including a meeting for stakeholders. In addition, Fordham Road Reconstruction Project was substantially completed except for plantings in the median\_ Formal ULURP for Fordham Road Rezoning to commence in 2013 with DCP as lead agency\_ and Fordham Plaza Redesign & Reconfiguration Project will commence on 2 January 2013.
