Fordham is engaged in seeking and obtaining certain Land-use approvals for the Re-Development and expansion of its Lincoln Center Campus in Manhattan under the NY City Uniform Land-use and Review Process (ULURP), which was commenced and coordinated, after application of Fordham, by the NY City Planning Commission (CPC) and the Department of City Planning (DCP) Staff. The Actions and relief sought include the granting of a special permit for height and setback requirements under existing zoning_ modifications of the requirements relating to the dimensions of inner and outer courts_ modifications of minimum distance between buildings_ modification of the minimum distance between legally required windows and certain walls_ and the minimum distance between legally required windows and zoning lot lines. Take together these actions, approvals and the ensuing relief granted will enable Fordham to implement its Master Plan for the redevelopment of its Lincoln Center Campus.
