The plans would also include a rezoning of Webster Avenue and ultimately Fordham Road and a change in the street name of Kazimiroff Boulevard back to its historic name of Southern Boulevard. This initiative also involves an attempt to improve the quality of life in the surrounding neighborhoods through aggressive street- scape plantings and increased enforcement of laws and regulations.
