## Subject Details

Obtain & maintain the support of New York City, its agencies, departments, boards, commissions and public authorities/corporations, including DOT, Parks, City Planning Department (DCP), DDC, EDC, Local Community Boards and the MTA, for the full approval, funding, design and implementation of a Conceptual Plan for the Revisioning of the Cultural District of the north central Bronx located around Bronx Park, Fordham Road, Southern Boulevard, Webster Avenue and the Mosholu. This effort involves the reconstruction and redesign of the emerald necklace of roadways & parkways, along with mass transit facilities, jointly constituting the gateways leading to the area's world class cultural, educational and research organizations consisting of the New York Botanical Garden, the Wildlife Conservation Society/Bronx Zoo, Montefiore Medical Center and Fordham University. The initial projects being launched include -- the reconstruction and re-engineering of Fordham Road from the Bronx River Parkway to Southern Boulevard, the rezoning of Webster Avenue and East Fordham Road, the Preliminary design for the Mosholu reconstruction, along with area tree plantings and alleviation of drainage and traffic issues. The focus this period was Fordham Road --- both the reconstruction and rezoning effort.
