How to Determine the Fee for Family Size 7 or More: Determine if the family's gross income falls below the maximum for the applicable funding stream. If it does, subtract **\$335** from the monthly gross family income for each family member above 6, and use the fee schedule for family size 6 to determine the fee. If family income after subtraction exceeds **\$5,907** (the maximum income for a family size of 6 for funding stream 14), the weekly fee will be set at the maximum fee of \$232 for full time care and \$174 for part time care.

Underlined Fee Bands (pages 2 and 3) end at 200 percent of the State Income Standard, which is the income eligibility ceiling for the Child Care Block Grant. **Families with high incomes (below the solid lines)** can only be assigned to Funding Streams 05, 09, 14, 20, or 21.

Parents who are eligible for Public Assistance, but who choose child care in lieu of Cash Assistance, will pay a weekly fee of \$15 for full time care and \$12 for part
