Your response to this survey is required as it will provide two crucial pieces of information:

- Whether EarlyLearn NYC center-based programs are in compliance with the NYC Food Standards as required by law
- How ECE can offer additional support to help you implement and operationalize these standards to your program's benefit.

Each year, ACS reports to the Mayor's Office and the NYC Department of Health and Mental Hygiene (NYC DOHMH) on the status of ACS' contracted agencies' compliance with the food nutritional standards. Additionally, the information on these NYC Food Standards status reports is also presented to the City Council.

### **Attention EarlyLearn NYC Programs: Extension of Pre-K Registration Deadline to Friday, June 26**

The pre-registration deadline has been extended to Friday, June 26. Please review the three important things that you need to do this week as a result of the extended deadline.

1. **Please contact all families who have not yet pre-registered** for their offers to your program and invite them to pre-register before Friday, June 26.
2. **All pre-registrations should be entered using the offer list in Pre-KIDS.** Through Friday, June 26, you will only be able to pre-register students who received offers from the NYCDOE.

3. **Please DO NOT MAKE ANY waitlist offers until after the new pre-registration deadline.**

Students are not listed on your Program Candidate List (PCL) in SEMS in the correct waitlist order. You **MUST WAIT** until your official waitlist is available in SEMS on **June 27** to make waitlist offers for available seats. Step-by-step waitlist management instructions will be provided later this week.
