



Dear Provider Community:

I am pleased to join with Commissioner Cecile Noel of the Mayor's Office to Combat Domestic Violence (OCDV) in announcing the creation of the Healthy Relationship Training Academy's Foster Care Initiative to address a compelling need and a critical piece of domestic violence prevention. Through this initiative, youth ages 11-21 in the New York City foster care system will learn about dating violence and the tools needed to build healthy relationships. Studies show that 1 in 10 New York City high school students in an intimate partner relationship reports being physically abused by their boyfriend or girlfriend. It is essential that we educate youth about healthy relationships beginning at a young age.

This Initiative is part of the OCDV NYC Healthy Relationship Training Academy and includes workshops facilitated by Peer Educators, ranging in age from 17 to 25, that engage youth in frank discussions and critical thinking about these challenging topics. In 2014, the Academy conducted approximately 300 workshops, reaching a total of more than 7,000 young people, 230 parents, and 500 youth based organization staff in schools, community based organizations, faith-based institutions, homeless youth walk-in centers, alternative to juvenile detention facilities, summer youth employment programs, young adult internship programs and continuing education programs.

As this initiative launches, we will train ACS and our provider agency staff to reach foster parents and youth in care. During November and December, we would like to work closely with your Foster Care and Juvenile Justice Program Directors to plan the implementation of trainings and workshops for agency staff, youth and foster parents. This effort is being coordinated by Elizabeth Falcone, OCDV's Director of Youth Programs at the Mayor's Office to Combat Domestic Violence and Courtney Ramirez, ACS' Executive Director of Family Engagement & Youth Advocacy. This project is a fully funded project of the Mayor's Office and the trainings/workshops will be provided at no cost to the agencies.



[B2H SED Now Accepting Applications](#)

We are now accepting applications for the B2H SED (Serious Emotional Disabled) waiver, effective October 15, 2015. At the beginning of the year, we notified providers that we had reached our capacity in B2H SED and were forced to implement a waitlist. We are only allowed to maintain 150 children on the waitlist, and since we only have the capacity to serve a predetermined number of children at a time, our waitlist will continue to fluctuate. We will keep you posted periodically as to its status.

The Developmentally Disabled (DD) waiver continues to be closed and not accepting any new referrals.

We currently have vacancies in the Med-f (Medical Fragile) and C2H (Close to Home) waivers, so do not hesitate to send in applications.

Visiting Youth in Juvenile Justice Placement Facilities

The policy was approved and signed by the Commissioner on October 28, 2015. Regular visiting between youth in juvenile justice placement facilities and their families and other important people in their lives is critical for sustaining and strengthening those positive relationships necessary to support youths' rehabilitation, well-being, and development into adulthood. It is the responsibility of juvenile justice placement provider agencies to arrange and facilitate agency visits between a youth and his or her parents/guardians, siblings, half-siblings, children, extended family or other discharge resources, and other persons of significance to the youth as long as such visits are not prohibited or restricted by court order and would not compromise the safety of youth, staff, visitors or security of the facility. This policy applies to juvenile placement facilities having care and custody of youth placed with ACS according to Article 3 of the Family Court Act.

Limited Secure Placement Personal Youth Search Policy

This policy was final approved and signed by the Commissioner on October 28, 2015. The purpose of this policy is to provide clear guidance for staff to follow with respect to personal youth searches. Limited secure placement (LSP) providers are required to implement search policies and practices designed to maintain contraband-free programs throughout the LSP system. The primary purpose of any personal search is to protect the safety of youth and staff in the LSP facility, the community, and others who may be present, within a context that respects and promotes dignity and healthy relationships through effective communication, making empathetic connections, being sensitive to a youth's abuse and trauma history, and establishing a structured, consistent environment. This policy makes clear the circumstances under which personal searches described in this policy are mandatory, and the circumstances under which such searches are to be conducted at the discretion of facility staff and/or Administration for Children's Services (ACS) staff. LSP providers are expected to make determinations regarding the need for personal searches based on ongoing assessments of the level of trust and open communication with individual youth and to conduct searches within the broader context of a conversation about personal responsibility, safety, and trust.
