PRIVATE CARTER COMMERCIAL RECYCLING AUTHORIZATION LIST

Pursuant to the new Commercial Recycling Law and Rules, the New York City Business Integrity Commission has reviewed the applications submitted by private carters and has granted authorization to the carters listed below to utilize the following commercial recycling collection methods. If a carter has been authorized by BIC to perform single-stream recycling collection, they may also perform co-collection and source-separation of recyclable materials. If a carter has been authorized by BIC to perform co-collection, they may also perform source-separated recycling collection, but not single-stream recycling collection.

Carters have to transport the designated recyclable materials to the appropriate recycling processing facilities according to the authorized method of collection, e.g., single-stream recycling collection and/or co-collection of recyclables.
