***COMMISSION DIRECTIVE***

Dear Licensee,

On August 24, 2018, The New York City Business Integrity Commission (the “Commission”) suspended Sanitation Salvage Corp.’s (“Sanitation Salvage”) license to collect trade waste from businesses located in New York City. Therefore, as of today and until further notice, Sanitation Salvage is not authorized to service customers in New York City.

The NYC Department of Sanitation (“DSNY”) will offer affected commercial establishments up to two weeks of temporary collection services as needed through Friday, September 7, 2018. After September 7, 2018, DSNY will cease all temporary collection services and the affected commercial establishments will be required to obtain trash and recycling services from a licensed private carter for the remainder of the time Sanitation Salvage’s license is suspended.

The Commission and the DSNY have provided the affected commercial establishments with information about how to contact licensed private carters to obtain temporary collection service while Sanitation Salvage’s license is suspended. Beginning today, you may solicit the business of the affected commercial establishments. You may immediately begin providing collection services and continue to do so while Sanitation Salvage’s license is suspended. In an effort to help the affected commercial establishments quickly obtain temporary trash and recycling collection service, enclosed is a list of the names and contact information of the affected businesses.

If an affected commercial establishment contacts you to obtain temporary trash and recycling removal service, you may not refuse service to the customer if the customer is located within ten blocks of one of your existing customers, unless the you are able to demonstrate to the Commission a business justification for refusing to service that customer. *See* Admin. Code § 16-520(g).

**You are directed to notify the Commission of all agreements you reach with the affected commercial establishments by the close of business of the same day that you reach such agreements. To provide notice to the Commission, complete all fields in the attached excel sheet and email to [licensing@bic.nyc.gov](mailto:licensing@bic.nyc.gov). The rate cap remains in effect and your invoices and billing practices remain subject to inspection and audit by the Commission. The Commission requires this information in a timely fashion to coordinate service with DSNY.**

If Sanitation Salvage attempts to contact you for any reason, including to sell or otherwise distribute customers, or you have any information about any anti-competitive practices, please contact the Commission complaint hotline at (212) 437-0600. You may make an anonymous complaint.
