BIC agenda items

- Enforcement update
 - Current issues BIC is seeing include helpers riding on the hopper and leaving the hopper open. Enforcement will continue.
 - BIC has also seen failure to maintain daily vehicle inspection reports (DVIRs);
 drivers must be cognizant of compliance and enforcement.
- Amended rate cap rule goes into effect on June 24th
 - o Carters or others who wish to present BIC with information concerning another potential rate cap adjustment may do so at any time.
- Customer Registers for Q2 2022 are due July 31, 2022.

- o Customer register data for **April 1, 2022** through **June 30, 2022** must be submitted to the Commission no later than July 31, 2022.
- o All companies must provide complete, reliable data by the deadline; extensions will not be permitted, and violations will be issued.
- Side guard requirement deadline January 1, 2023
 - o In the coming weeks, BIC will send a notice with instructions on how users can upload vehicle-specific proof of compliance with the side guard requirement in the BIC Online Portal before the requirement takes effect on January 1.

Agenda items requested by non-BIC TWAB members

- In response to a request for clarification regarding BIC's rule requiring six-month vehicle inspection reports (17 RCNY § 5-10(e)), BIC confirmed that those reports are intended to provide an accurate snapshot every six months; the forms referenced in § 5-10(e) are not dynamic forms that need to be revised after every repair and completed inspection.
- TWAB members raised two additional issues, which will be addressed at or before the next TWAB meeting: charging delivery fees for containers, and meeting requirements regarding defensive driving courses [17 RCNY § 5-14].
