Approval of February 8, 2022 Minutes

Acting Chair Medina convened the meeting and asked for a motion to approve the draft minutes of the Board's February 8, 2022 meeting. Upon Member Safyer moving the item and Member Franco seconding it, the minutes were unanimously approved, 5-0 (Acting Chair Medina and Members Cohen, Franco, Safyer, and Rigterink; Members Carrion and Sherman had not yet joined the meeting). Opening Remarks/Announcements

BOC Interim Executive Director Amanda Masters ("Interim ED Masters") summarized the latest census data and COVID data, which will be posted on the Board website in a slide deck. See this portion of the video recording here.

Interim ED Masters remarked on the death of Tarzs Youngblood in DOC custody on February 27, 2022. Mr. Youngblood's death is under investigation by DOC's Investigation Division, the New York State Attorney General and by BOC. See this portion of the video recording here.

The Board expressed condolences for DOC staff who passed away in the past month. Interim ED Masters updated the Board on concerns brought by COBA representative Ashaki Antoine at the prior meeting, including institutional hot pot water temperature, gang housing and planned repairs on gates, doors, and locks throughout the system. Acting Chair Medina discussed February 25, 2022 meeting with DOC's Commissioner Louis Molina ("Commissioner Molina") and his staff, during which DOC updated the Board on the progress of de-escalation units and RMAS implementation. Acting Chair Medina also spoke on transforming Rikers using restorative justice principles and collective efforts following his tour of GRVC with Correctional Standards Review Specialist II Melendez and Interim ED Masters. Acting Chair Medina encouraged all stakeholders to get involved to improve conditions in Rikers and prevent further deaths. See this portion of the video recording here.

DOC Commissioner Updates

Acting Chair Medina welcomed Commissioner Molina to deliver DOC's opening remarks and to discuss RMAS progress. Commissioner Molina thanked the Board for remarking on the death of Mr. Youngblood and expressed his condolences to Mr. Youngblood's family. Commissioner Molina also thanked the Board for their condolences on the passing of DOC staff and expressed condolences to their families.

Commissioner Molina spoke on the Department of Education chancellor's visit and educational access in jails including an additional schoolhouse, increased use of credible messengers, and faith-based outreach. Commissioner Molina noted increase in staffing levels and engagement with staff who have not returned to work. Commissioner reported that there are currently three de-escalation units running and plans continue to add more in the coming weeks. On RMAS implementation, Commissioner Molina confirmed DOC's commitment to comply with July 1

deadline remains firm. Commissioner Molina remarked on violence indicators in jails, balancing population based on gang affiliation and reducing Use of Force in facilities. See this portion of the video recording here.

RMAS Implementation Update

Commissioner Molina described RMAS implementation work and goals. DOC General Counsel Asim Rehman spoke on DOC's compliance with HALT Act deadlines and coordinating with defense organizations on technology and operational matters. DOC Executive Director of Policy and Intergovernmental Affairs Steven Kaiser provided update on reports and reporting templates, training, policy, and construction. DOC Deputy Commissioner for Programs and Community Partnerships Francis Torres spoke on programming and counseling services by level. See this portion of the video recording here.

Board members' questions touched on educational plans, Executive Order allowing young adults and adults commingling, lack of staffing data reporting to the Board, use of Executive Orders, initial notification of Mr. Youngblood's death to the Board, *The New York Times* article on improper documentation and reporting of serious injuries in the last year, lockout measures that fall outside of the rubric of HALT Act, logbook audit practices, and de-escalation units openings and use. Interim ED Masters also introduced questions from BOC staff about the use of "cages" or "quads" in GRVC, number of overdoses, and number of fires and what has been done to prevent them.
