Implementation Update: The Department has implemented the recreation plan as previously submitted to the Board. The facility continues to afford young adults the daily opportunity to engage in outdoor recreation, as well as additional supplementary activities; however, each individual may opt to decline as they see fit. Young adults continue to state that they would rather opt for inside programming than outdoor recreation. In order to continue to follow social distancing guidelines programming staff were limited in their ability to facilitate regular structured activities in ESH in the month of January. The Department continues to provide books, as well as cognitive skills therapeutic packets within the unit. Further, in the month of January ESH security staff continued to offer individuals in Level 3 the supplemental opportunity to go to the gym area. This is a progression incentive offered specifically to those in Level 3.
