<sup>1</sup>Data in this table represents contraband surrendered by individuals following placement in Separation Status, recovered from individuals following placement, or recovered from the Separation Status unit following or during an individual’s placement. Contraband is also recovered through the use of body scanners, without the use of Separation Status. In December 2019, five (5) contraband items were surrendered immediately following a scan. Historically (July 2019 through December 2019) seventeen (17) contraband items have been surrendered prior to a scan and forty-eight (48) items have been recovered immediately following a scan. These numbers have been adjusted for accuracy from last month’s report, as a reassessment determined that more items than previously reported had been recovered.
