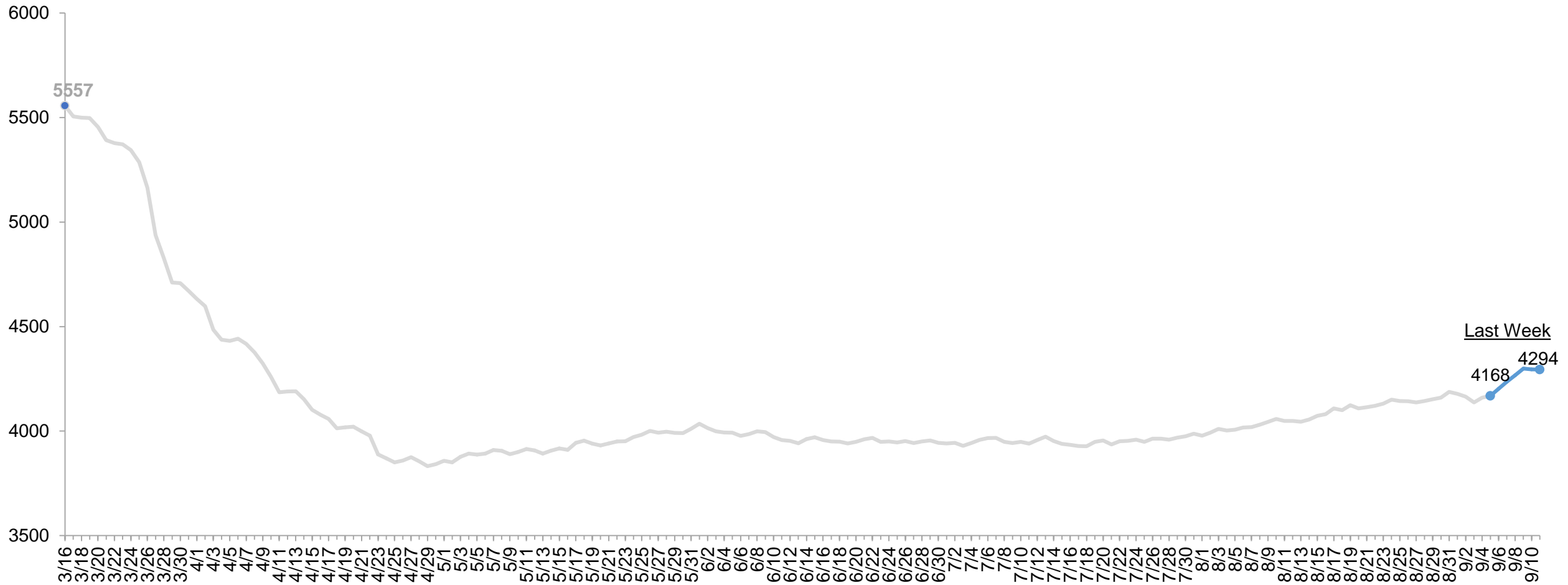

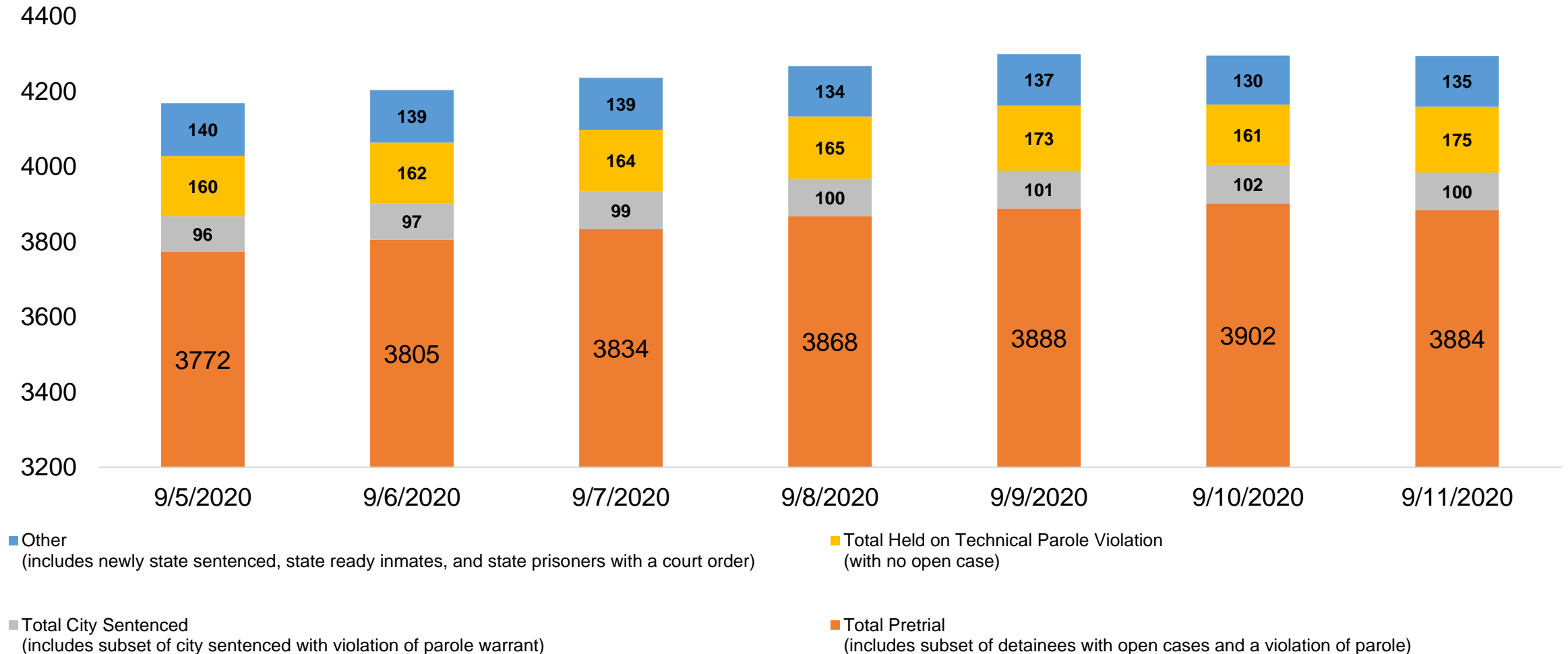
**Total Population in DOC Custody

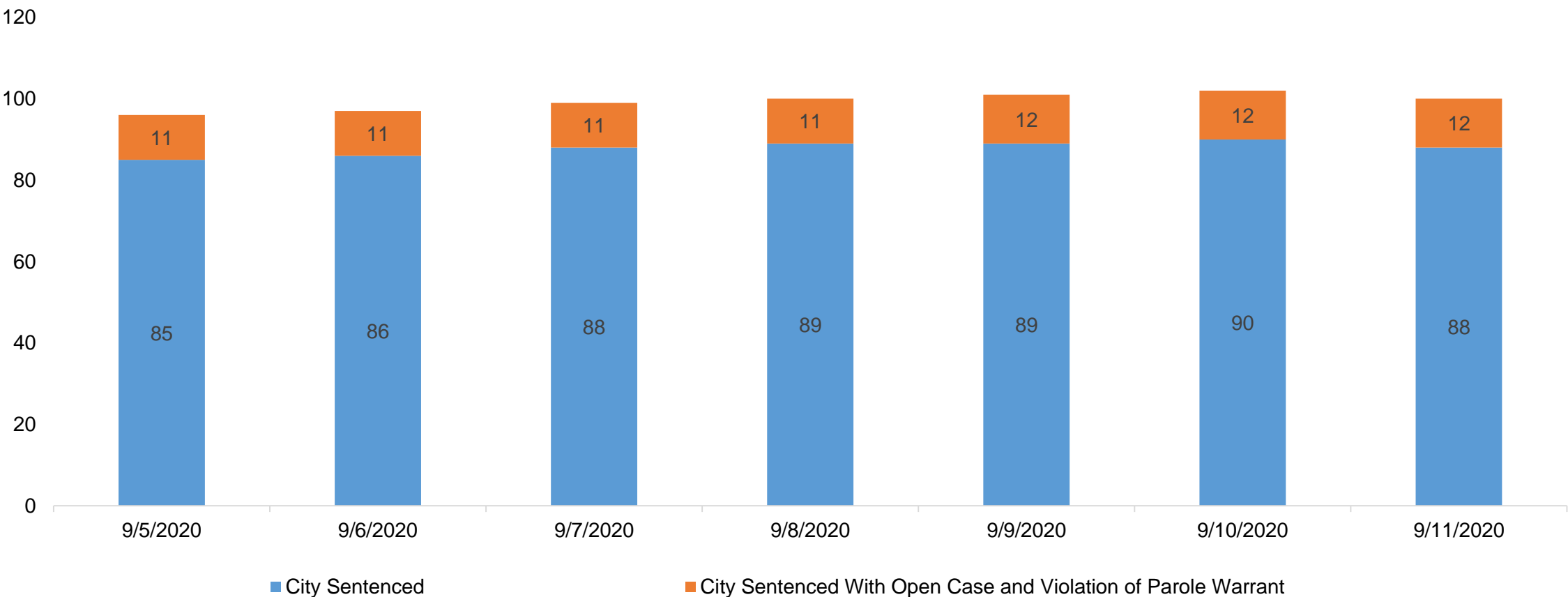

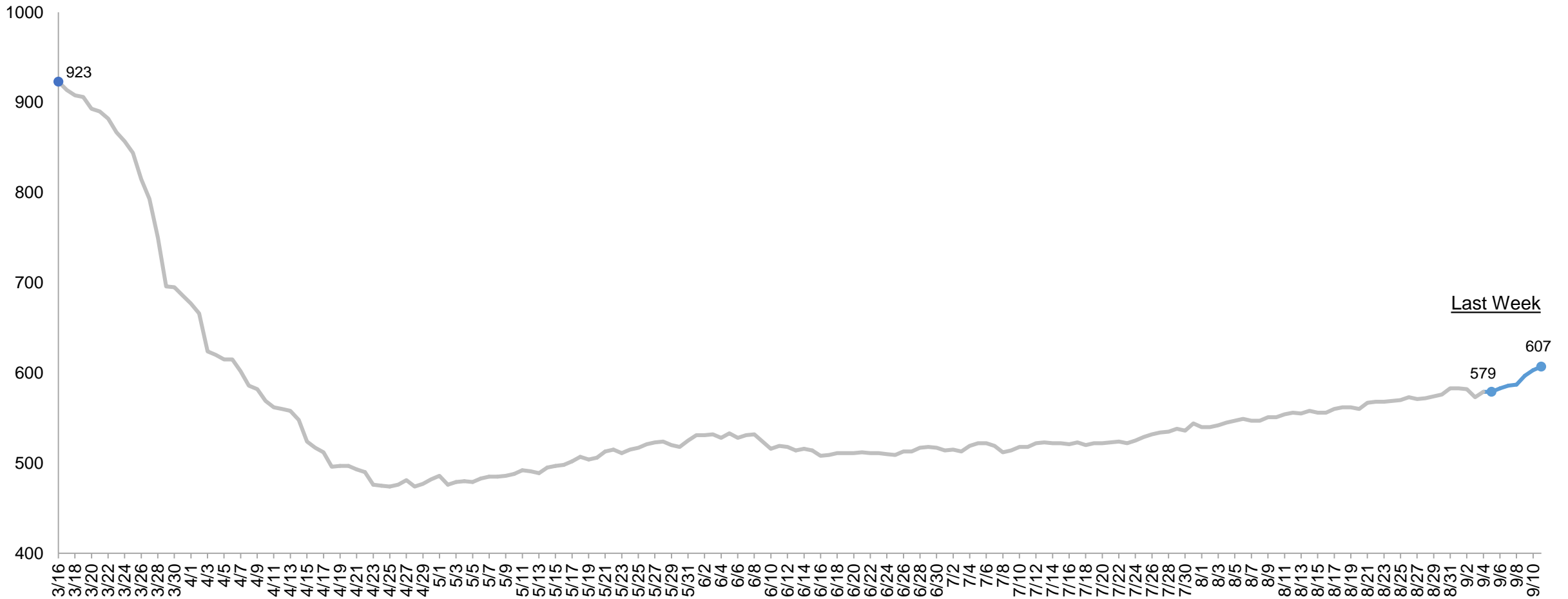

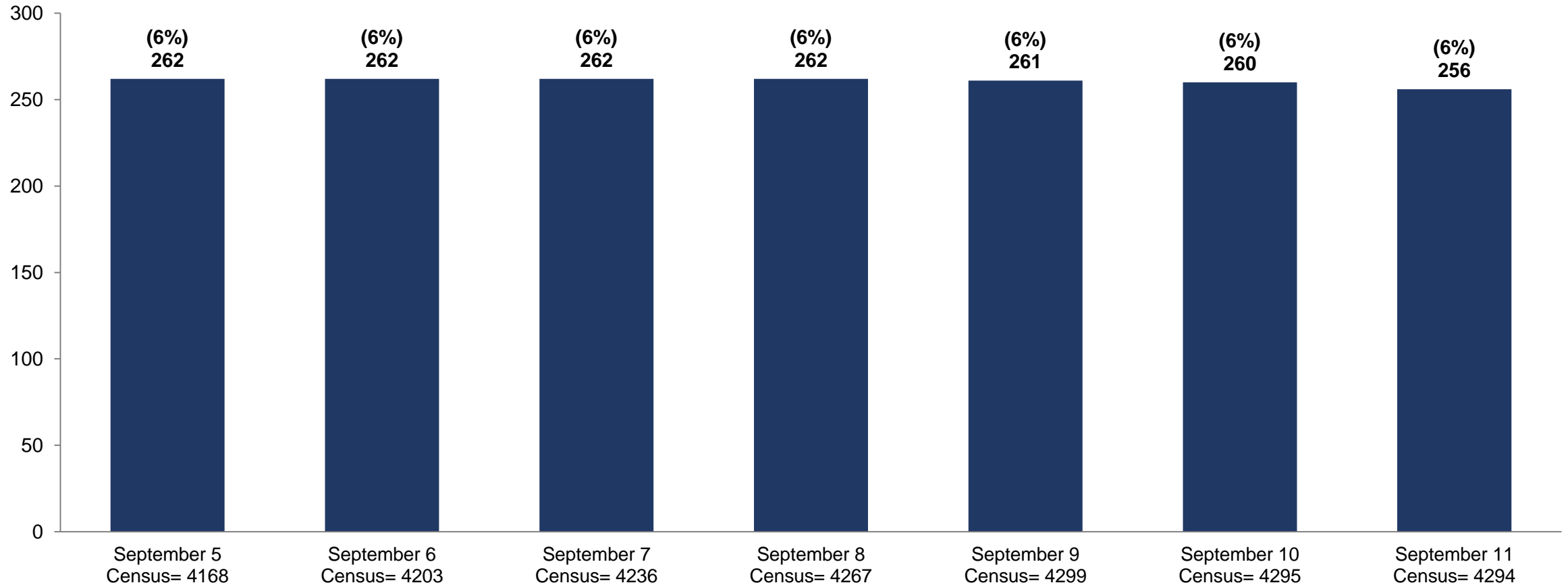

September 5 - September 11, 2020

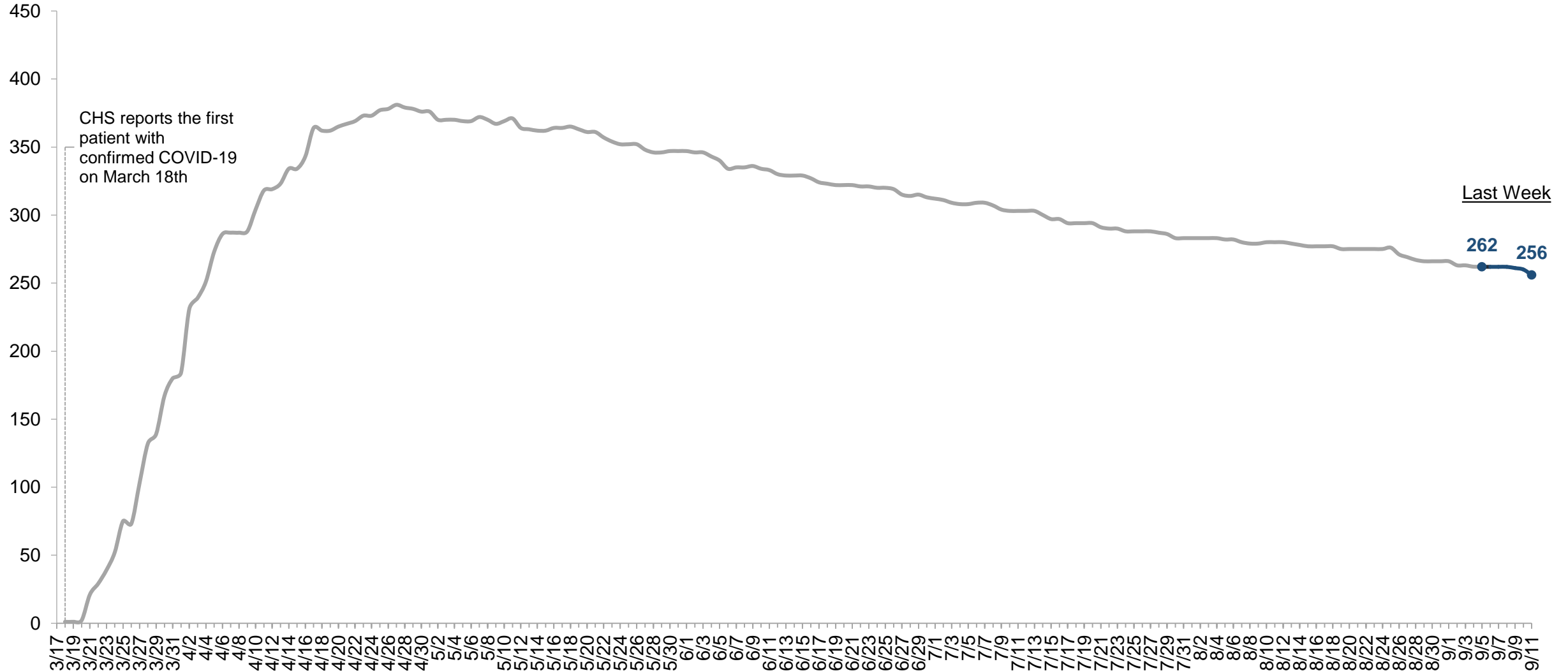

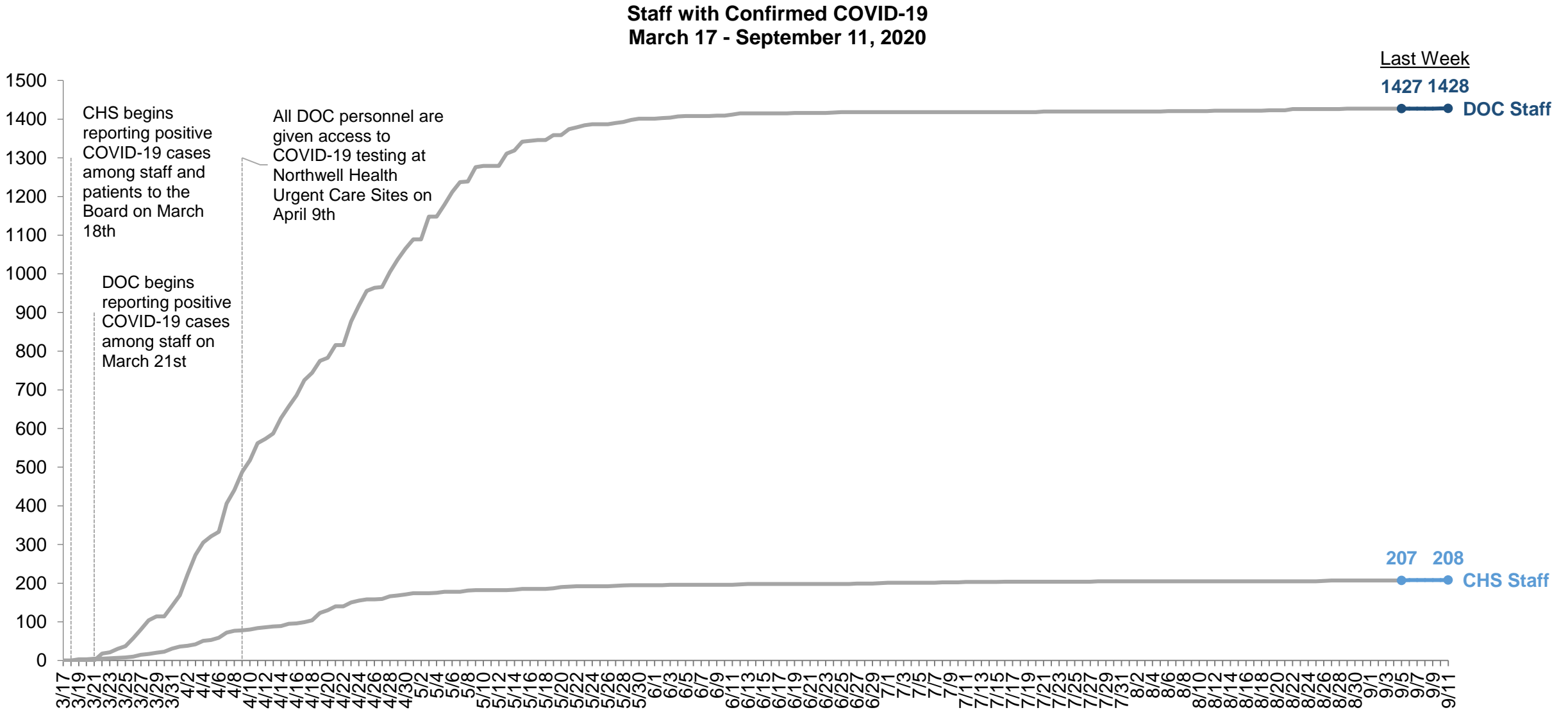
Number of Currently Incarcerated Patients with Confirmed COVID-19

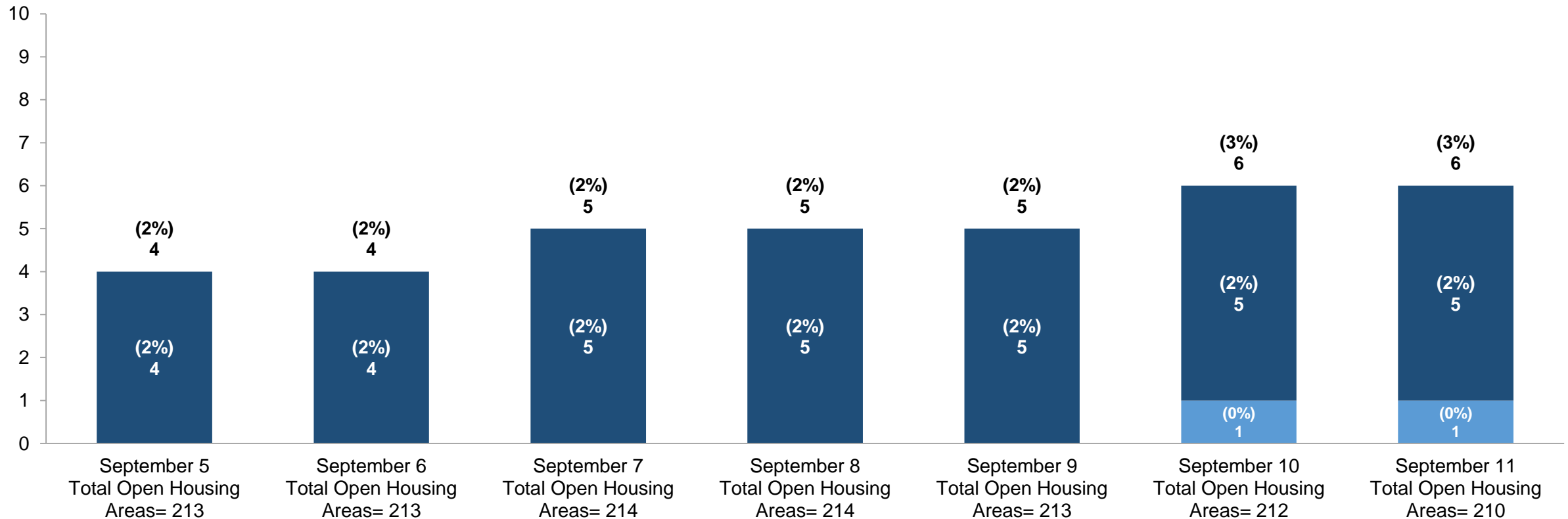

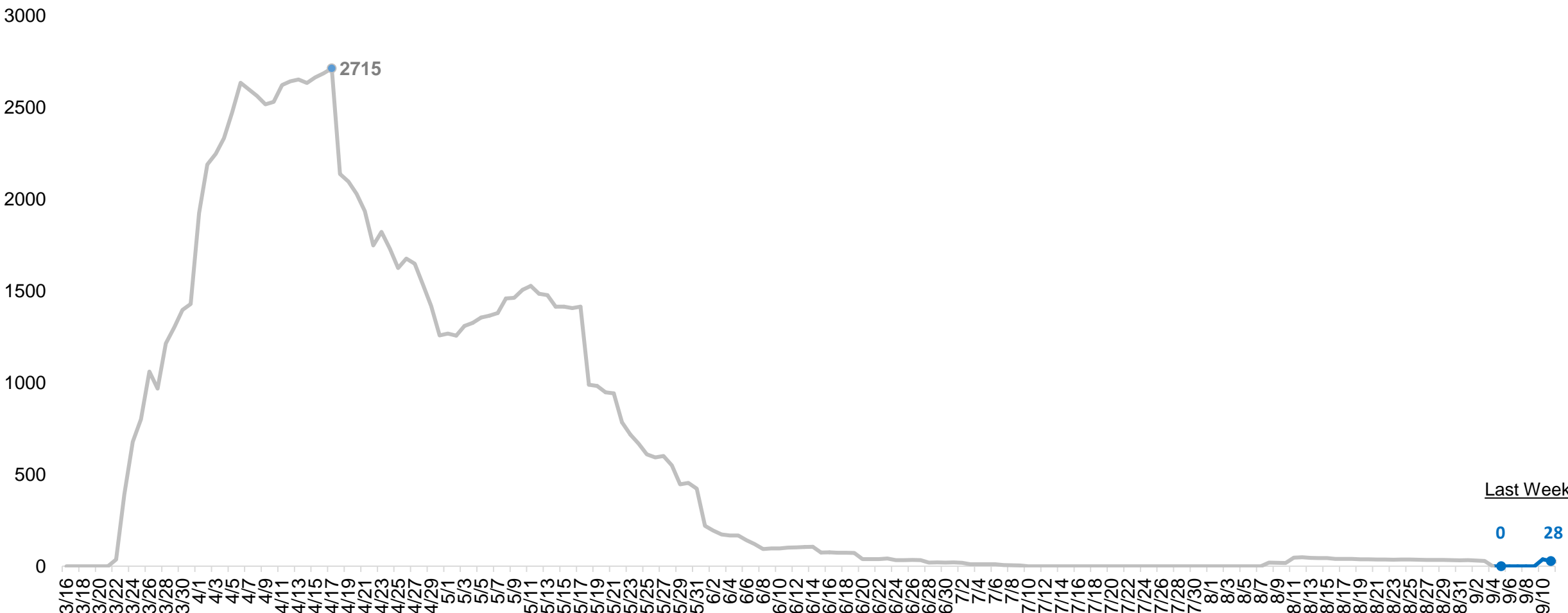

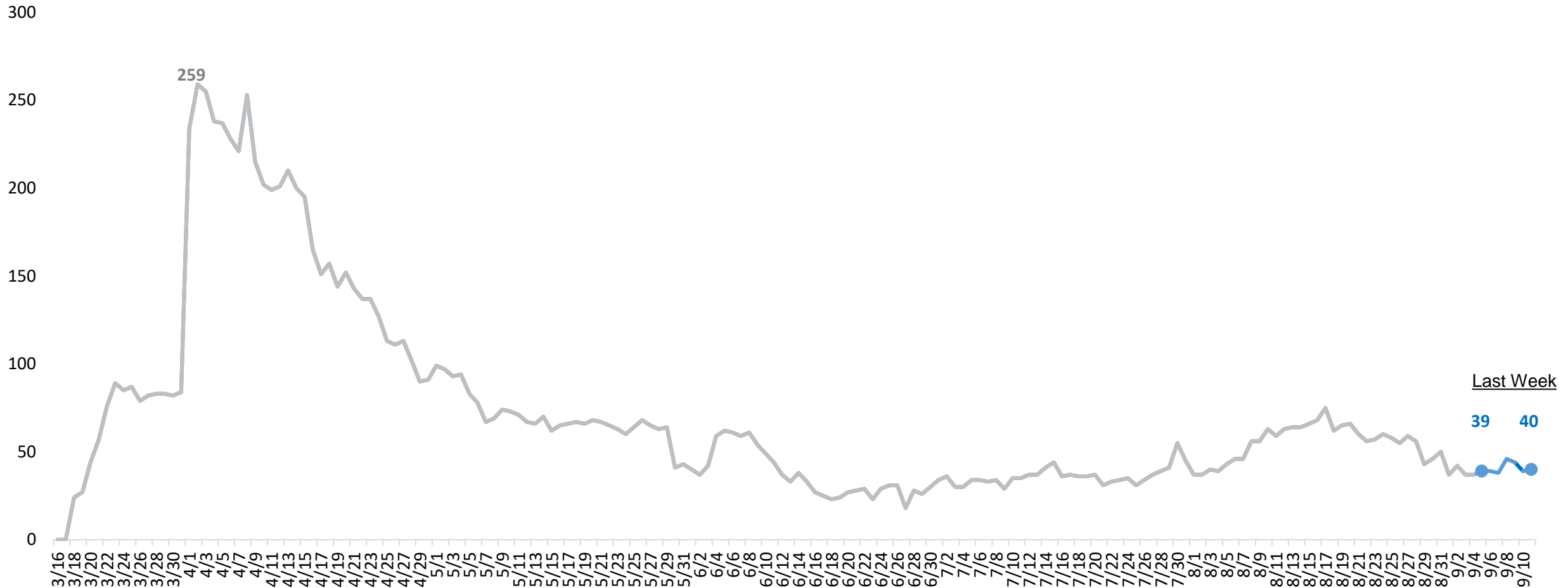

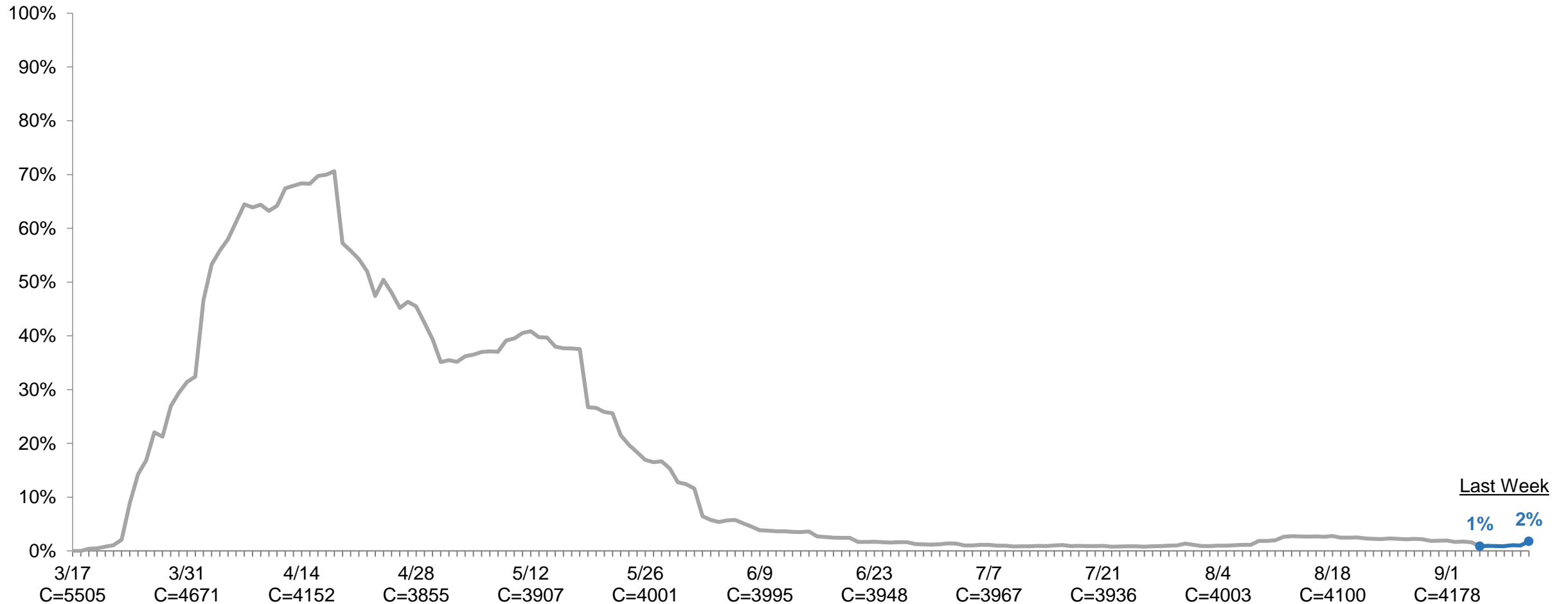

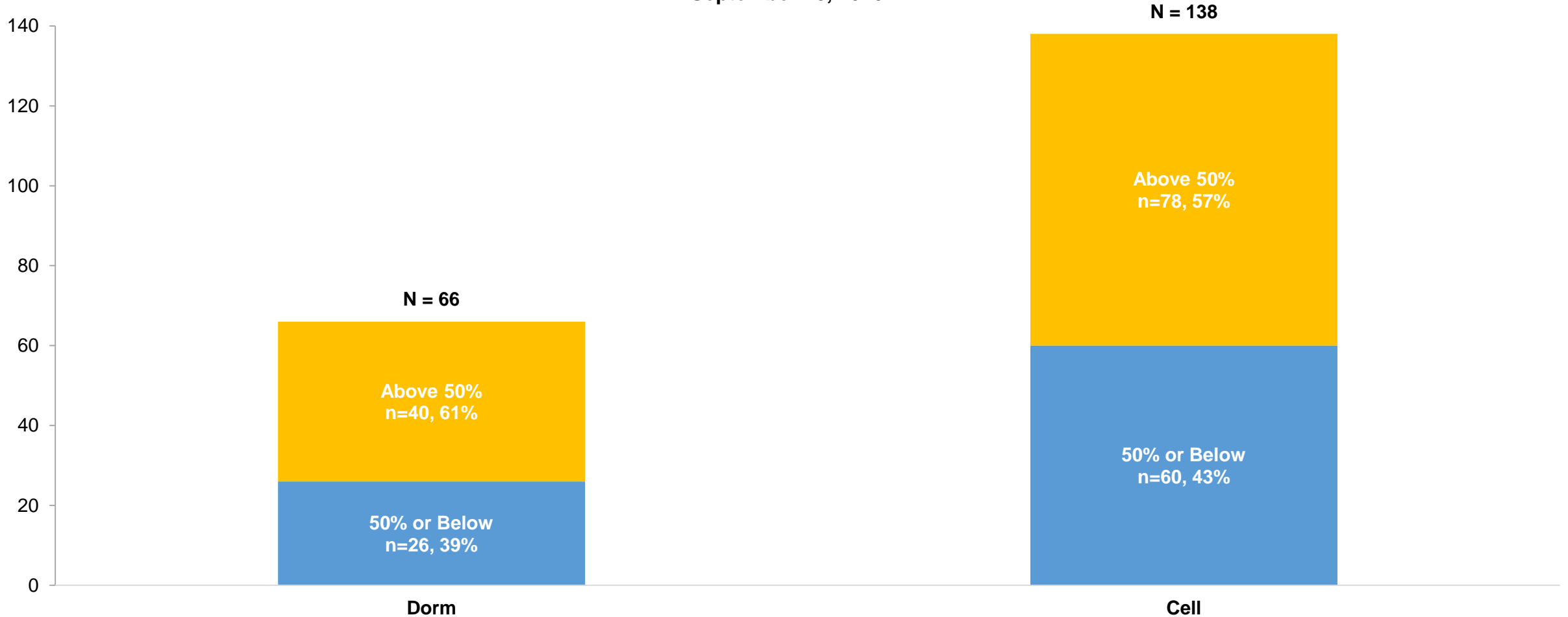

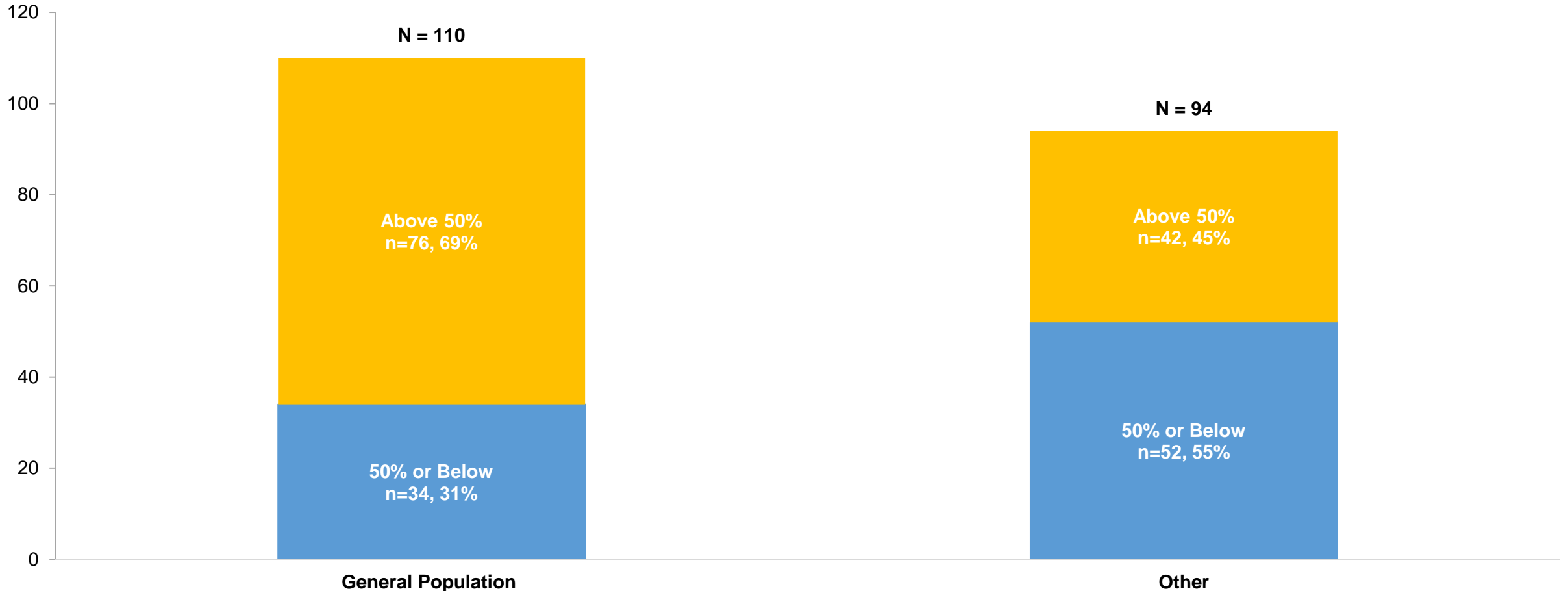
