The meeting began at 7:30 PM with the Pledge of Allegiance.

Mr. Accomando acknowledged all in attendance and thanked them for attending the Committee meeting. Before addressing all the representatives in attendance Mr. Accomando introduced the newest member to the committee, Mr. Tremaine O'Garro, and asked him to address the Committee. Mr. Accomando then went on to address the representative and asked each establishment to state name and position when called upon.

The Committee then went on to address the Renewals. Mr. Accomando called on each establishment separately and went over the PO Reports on each establishment. There was a very good turnout of establishments that attended the meeting. 

The Committee recited the Pledge of Allegiance to begin the meeting at 7:27 P.M. The committee led with the Shore Road presentation from NYC DDC. It is not a capital funded project. It is a capital project scoping development study which is to identify existing conditions and then determine costs. Flooding and erosion are some of the concerns. Raising the roadway roughly 4 to 7 feet could be helpful at addressing street flooding. Higher elevation will lead to higher construction costs, tree removal and disturbances to wetland area. Multi use path is 9 feet. It would have to be 15 feet because accessibility regulations. This would also require the removal of trees, disturbance of wetlands and significant coordination with Westchester County. It could increase construction by \$2 million. The project could cost up to \$50 million. A maintenance agreement is required to determine which agency will work to monitor the roadway after construction is completed. Committee members asked whether the environmental impact could be lessened. Board Members want to see roadways that are not as affected by municipal concerns such as salt from a snowstorm.

T. Accomando proposed a resolution to send a letter to Council Member Velazquez and Mayor Adams to fully fund the Shore Road reconstruction. D. Noble seconded. All committee members present voted unanimously.

There was a complaint registered about the water main break. There is an issue with Exit 14 southbound that the constituent would like the District Manager to handle. District Manager Cruz will follow-up with the constituent personally.



#### Minutes 11/23/2021

Attendees: Bishop Nancy Rosario, Col. Chin, Tom Smith, Mary Jane Musano, Debbie Hunt

Began at 7:05 pm with pledge of allegiance and greetings.

First Speaker: Shawn Kingston from James J. Peters Veterans Medical Center. He is Dir of Center of Development and Civic Engagement. Informed us of two retirements occurring at the VA: The Medical Center Dir – retiring 12/2021., and Chief Executive Nurse – retiring 1/29/22. VA is going through a renaissance, many are retiring.

Booster vaccines are provided for veterans and their spouses and caregivers. Also, flu vaccine for vets Mon-Fri 8am-4pm.

November is Veteran's month – Boro President Ruben Diaz Jr. distributed turkeys, gift bags, lunches, etc. Everyday is Veterans Day.

VA is always open for outpatient visits and virtual care. They encourage all veterans to apply for benefits even if they have private insurance.

Next speaker was Diane Cooper – Dir and founder of Caregivers Outreach Ministry Empowerment for the past 15 years. She gave pertinent information on how caregivers can apply for benefits and care. All caregivers should apply, the dynamics are different for each family. It is important for caregivers to know that Discharge Planning begins the moment the patient is admitted to the Emergency room. When the hospital questions who the patient lives with, they are talking about discharge planning. She encourages all caregivers to asks as many questions as you can. There is a law coming in 2022 when you apply for Community Medicaid, all you have to show is a One Month statement. In 2023, the statements will require 2 ½ years. She gave her #347-691-8272 and comeoutreach.org.

She also gave advise to caregivers to take care of yourselves, do not forget your own meds, doctor appointments, appointments, etc.

Community Medicaid is: instead of family member being placed in a nursing home, you can get home care, home health aide, therapy.

Shawn Kingston also mentioned that James J. Peters VA has an extensive Caregiver Program. Diane Cooper also advised that 5 years ago they began a program called the Young Sharks. A research was done on youth caregivers out of 454 youth interviewed, 197 were caregivers. They helped to minister, insulin, catheters, etc. They have reached out to medical facilities, to advise if they see a youth coming to appts with a parent, grandparent, etc.

Speaker: Aminou ?? and Navneet ??? Health care professional and graduate student. They informed that there is a Bill – S828 for the NYS Dept of Ed Public School Food System, to regulate Halal lunches for public school with 500 or more Jewish and Muslim students.

43 schools in NYC already provide Halaal and Kosher food at religious requests.

Bill is in committee. The committee agreed to send a letter of support.

The meeting concluded at 8:45 pm.
