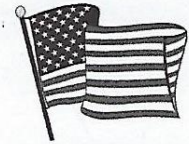

### **Economic Development Committee Meeting Wed, Nov 3, 2021**

Present: T. Accomando, B. Bieder, T. Chambers, A. Chirico, J. Onwu, L. Popovic,

The meeting began at 7:30 PM with the Pledge of Allegiance.

Mr. Accomando acknowledged all in attendance and thanked them for attending the meeting. He addressed all the representatives and asked each establishment to state name and position when called upon.

The Committee addressed Renewals. Mr. Accomando called on each establishment separately and went over the PO Reports on each establishment. There was very little to report and some suggestions were made to help the establishments going forward. After a discussion between the establishments and the Committee members, the Chairman made a motion to accept the Renewals and was made by Mr. Chirico and seconded by Mr. Bieder. The vote was unanimous.

- Applebee’s Grill & Bar, 2276 Bartow Ave, 10475, between Co-op City & Bay Plaza Boulevards, License # 1004241, which expires on 11/30/2021.
- Estrellita Poblana 1, 2227-2231 Westchester Ave, 10462, between Glebe & Castle Hill Avenues, License #1259128, which expires on 12/31/21.

The Committee then went on to address the new licenses and heard from the owner of Anthony's Restaurant. The discussion between the owner and the Committee went extremely well. Mr. Accomando stressed the importance of checking IDs when his waiters are serving alcohol. At this time the Chairman made a motion to accept the Renewal. It was made by Mr. Smith and seconded by Mr. Popovic. The vote was unanimous.

The Committee then went on to address the next Renewal, Two Friends Real Estate, and after a very brief discussion a Motion to table was made by Mr. Bieder and seconded by Mr. Popovic. The vote was 6 to 2 in favor of tabling.

There was no Old Business.

New Business: Mr. Bieder pointed out that after a motion to table is made and voted on, no further discussion is to take place as per parliamentary procedure. Note: Mrs. Chambers made an excellent observation that we shouldn't be so fast to make a motion to table without a thorough conversation. Mr. Accomando strongly agreed. He informed the Committee that there was a meeting that took place between the District Manager Mr. Cruz, Committee Chairman Mr. Accomando and Sergeant Major prior to this application. Sergeant Major requested this meeting because the landlord was using the parking lot to host events without permits and serving alcohol as well. The new applicant was present at this meeting to state he was not involved in those events. At this meeting we discussed what was permitted and what wasn't and applicant fully agreed to comply.

Mr. Accomando informed the Committee that the Co-Chair Mrs. Acampora has moved and is no longer a CB 10 Member. Mr. Bieder made the motion to nominate Mr. Tom Smith for Co-Chair and it was seconded by Mr. Chirico. The vote was unanimous and Mr. Smith graciously accepted the position.

A motion to close the meeting was made by Mr. Bieder and seconded by Mr. Smith. The meeting ended at 8:55.
