Joint Meeting of Municipal Services and Parks & Recreation committees began promptly at 7:30 PM with the Pledge of Allegiance.

Five Street Activity Permits was reviewed and voted on. They were all approved unanimously. One – Fairfax Avenue Block Party - was submitted with a pending date change; it was approved for the pending date.

Following that we discussed a request for a letter of support for the Crosby Cabs/Zero's license renewal. There are two licenses in question. We approved the request for a letter of support unanimously.

**“Resolved...**at the recommendation of the Municipal Services and Parks & Recreation Committees of Bronx Community Board #10 that a letter of support for the renewal of a Base Livery License for Tremont Dispatching be written to the NYC Taxi & Limousine Commission and that this be forwarded to the full Board for approval.”

Next, we provided with a preliminary overview of the proposed expansion of ferry service to Ferry Point Park. There are still several steps and reviews before any construction begins but the plan is to start the Ferry service at Ferry Point before the ferry goes to Soundview and proceeds into Manhattan. We raised concerns around traffic flow in-and-out of the proposed parking lot, access to the ferry (which will require a walk from the parking lot to the pier) and general questions about the service. Board members should request a copy of the presentation from the office. Future meetings and discussions will be held as this proposal undergoes further review.

New Business: The committee requests that the office look into:

1. Possibility of a stop sign at Glebe and Glover Avenues
2. Possibility of a stop sign at Parker and Lyons Avenues
3. Timing for the release of parking in front of the old Sisto Funeral Home; currently there is no parking signage in front of the location.
