## Call To Order

#### Invocation

#### Community Concerns/Exchange of Information/Announcements

Ms. Rosalinda Alvira, community resident stated that she is a member of the Crotona Park Dog Run/Park Committee, whose mission is to establish an active committee of dog owners who would like a designated area for their dogs to be allowed to roam and mingle with other dogs in an open space. The establishment of the Crotona Park Dog Park Committee is warranted in order to seek funding to construct a dog park. Currently the Crotona Park Dog Run/Park Committee committee does not have a 501© 3 Tax Exemption Certificate nor a financial fiduciary (sponsorship) to process any monies if they were to apply for a grant. Ms. Alvira noted that she and other representatives from the Crotona Park Dog Run committee testified at SS Gustavo Rivera's hearing regarding the proposed dog park. Ms. Alvira was encouraged to attend the Bronx Delegation Discretionary Funding Training to learn about the requirements and how to apply for discretionary funding. It was noted that the Crotona Park Dog Park Committee would have to partner with an organization that would submit the application on their behalf to be the financial sponsorship, since they do not currently have a 501© 3 Tax Exemption Certificate.

- It was mentioned that most grant funders generally require proof of a 501© 3 Tax Exemption Certificate and prefer to support organizations with a proven track record of fiscal responsibility and programming successes.
- Mr. Aubrey Mike, Board member raised a concern regarding abandoned parked vehicles that have expired registration stickers, no license plates, and covered up VIN# and this vehicles are not being ticketed. Ms. Ritter requested that Mr. Mike call 311 and get a service request number and forward a brief description of the complaint along with the location and 311 SR # to the board office for follow-up.
- Mr. Gilberto Constantinez, board member raised a similar concern regarding cars parking on Simpson Street with paper license tags and covered up VIN numbers. Mr. Constantinez was instructed to call 311 to report the complaint, provide the location and forward the 311 SR# along with a brief description of the complaint and location and forward to the board office for follow-up.

## **Elected Officials' Reports**

## CM Althea Stevens - 16th Council District

Councilmember Althea Stevens thanked Rev. Rivera for his introduction and his well wishes. CM Stevens noted that this was her first Bronx Community Board Three meeting in her new capacity as Councilmember of the 16<sup>th</sup> council district. CM Stevens stated that she is interested in hearing about the communities concerns.

The Councilmember's office staff is working virtually due to current office renovations. CM Althea Stevens and her staff will be working at the same office located at 1377 Jerome Avenue. A "**Grand Opening**" of the CM office is anticipated in the coming weeks and the community will be invited.

CM Althea Stevens is in the process of creating advisory councils. CM Stevens believes in co-governance and making decisions with the community and stakeholders. CM Stevens wants to hear from the community-at large allowing ample opportunity via council meetings for people to have their voices heard and their concerns addressed.

The following Advisory Councils will be formed:

- Senior Services Council This council will assist in developing programming as well as identify funding sources for the senior population.
- Youth Council This council will be led by young people and exclusively for young people. The youth of tomorrow require a space where they can learn how grow into leaders with other like-minded peers in their community.
- **Health and Wellness Council** This council will focus on #Not62, discuss healthy food options/access along with identifying ways everyone can become more active through virtual and in-person exercise programs.
- Multicultural Council This council will celebrate all cultures and identities to promote unity within the community.
- Housing Council This council will discuss housing strategies, housing organizers/advocates and block associations, etc.

CM Althea Stevens has requested that interested stakeholders are encouraged to contact her office and join one of the councils. CM Stevens introduced Mr, Jahtah Brown, Communications and Social Media Manager at the 16<sup>th</sup> Council District office. Mr. Brown noted that the CM and her colleagues will be hosting a Bronx Delegation Discretionary Funding Training on Wednesday, February 9<sup>th</sup> and anyone who is interested in understanding how to apply for discretionary funds is encouraged to attend.

#### **Budget Season**

As most folks are aware, the budget season is now in full effect. As we look towards the recovery from this pandemic, Council Member
 Salamanca has been a leading voice during budget hearings to ensure that the South Bronx gets its fair share of funding for programs, services and capital investments.

#### **Budget details:**

- Discretionary and Capital funding applications are now live and available on the council website at: council.nyc.gov
- For Discretionary Funding: The deadline to apply will be on **Tuesday**, **February 22**<sup>nd</sup>.
- For Capital Funding: Application deadlines vary depending on the source of the funding a group has requested. See below
  Thursday, February 24, 2022, 5:00pm: applies if your project requests any funding from Borough Presidents (including those groups that are also requesting funding from the Council or Department of Cultural Affairs)

Thursday, March 24, 2022, 5:00pm: applies if your project is only requesting funding from the Council and/or the Department of Cultural Affairs

#### **Community Cleaning**

Council Member Salamanca allocates funding for supplemental cleaning services in the district. If there is a particular corridor in the community
that needs to be cleaned, please contact our office for further discussion on the matter.

#### **Policy**

We are gearing up for the start of 2022-2023 legislative session.

- During the new term, CM Salamanca will continue to lead the Committee on Land Use, where he will help the new members of the City Council
  navigate the ULURP system in order to attain pro-community development.
- As one of the most experienced returning members of the Council, Speaker Adrienne Adams has selected CM Salamanca to serve on the Select Senior Leadership Team, a committee that will serve as a sounding board on many of the most pressing Council issues.
   In addition to being the Chair of the Committee on Land Use once more, CM Salamanca will be on the following committees:
  - Committee on Civil and Human Rights (new committee assignment)
  - Committee on Economic Development (new committee assignment)
  - o Committee on Oversight and Investigations
  - Committee on Public Housing
  - Committee on Rules. Privileges and Elections (new committee assignment)
  - o Committee on Sanitation and Solid Waste Management (new committee assignment)
- On February 8th, the Committee on Land Use, through its Subcommittee on Zoning, and the Committee on Consumer Affairs & Business
  Licensing, will hear testimony from the Department of City Planning and the Department of Transportation on the 'Open Restaurants' zoning
  text amendment. The joint committees will review the procedures that led to the executive order granting restaurants the ability to operate
  roadway restaurant space, and next steps in enhancing compliance and enforcement of the program should it be permanently extended.

## SS Luis Sepulveda's Report – 32<sup>nd</sup> Senate District

Mr. Ritchard Ewings, representative from SS Luis Sepulveda's office, provided a written report for the period cover January 12<sup>th</sup> including February 8, 2022 as follows:

Two important pieces of legislation that Senator Sepulveda's sponsor passed were the Committee on Crime Victims, Crime, and Correction. Both bills aim to dignify the lives of incarcerated individuals.

- Bill S2144 relates to the definition of an incarcerated individual with a serious mental illness in the mental hygiene law.
- Bill S2855 facilitates access to birth certificates and social security records of incarcerated individuals upon release.
- SS Sepulveda and his colleagues support Bill S2771 which requires DHS to notify Community Bards before establishing temporary housing or shelters in the community.

Also, the City 1 Committee, which Senator Sepulveda chairs, has begun its work and in the coming weeks, they will be discussing important legislation relevant to the city of New York. It is important that constituents log on to the Senate website and create a profile to follow the legislations of your interest and to receive updates.

Senator Sepulveda's office is open for in-person services by appointment only. The staff is assisting constituents with a variety of issues including applications to the Homeowners Assistance Fund, unemployment benefits, landlord-tenant issues, among other things. ## **Acting Assistant District Manager's Report**

Ms. Etta Ritter the acting assistant district manager provided the following report for the period of January 12th and including February 8, 2022 as follows:

- Bronx Community Board Three hosted a Fire Safety Training for Adults and Children which was successful. The Fire Safety Trainings for Adults and Children will be offered at least twice a year in December and June.
- Bronx Community Board Three will be hosting a Rat Academy Workshop on Thursday, March 31, 2021 from 6pm-7:30pm.
   Ms. Ritter encouraged the community at-large to call 311 and report sightings of active rat harborage and forward the service request number and location to the board office for follow-up.
- The NYC Department of City Planning has an initiative on "Good Urban Design" and is requesting feedback from stakeholders and community partners on "How would you describe the look and feel of your neighborhood?" Go to goodurbandesign.nyc to participate and let your voice be heard.

- The NYC Civic Engagement Commission and Public Agenda is hosting an "Introduction to Public Engagement Workshop" for all five boroughs. The workshop will enable Community Board leaders to strengthen their ability to engage with the public in a more inclusive, equitable and innovative manner. All are encouraged to attend.
- The NYC Commission of Human Rights has expanded its Human Rights Law protections to more domestic workers, including home health aides, nannies and babysitters, janitors and cleaners. NYCHRL is requesting to identify pathways to reach domestic workers and their employers before the new law takes effect on March 12, 2022.

## **New Business**

- Ms. Marilyn Johnson, board member and co-chair of the Education Committee, stated that she has a cooking program at East Bronx Academy for the Future for grades 6<sup>th</sup> through 12<sup>th</sup>, located at 1716 Southern Boulevard, within Community District Three. Ms. Johnson spoke on the following:
  - A woman is interested in teaching other women how to cook meals in a virtual environment and assist them with starting their own business on-line. Ms. Ritter instructed Ms. Johnson to have her contact the board office to discuss said project and or to be scheduled to come before the Health and Human Services Committee.
  - Ms. Johnson also noted that she is focusing on 'mental health" and she is requesting that young adults aged 12 through 18 do a 3 minute video on their experience of COVID and how the pandemic has affected their lives and forward via email to: mjohnson@eastbronxacademy.org.
- Ms. Linda Kemp, board member and TA president at Robert Fulton Terrace, located at 530-540 East 169<sup>th</sup> Street requested an inspection
  of the self-closing doors and Emergency Exit doors at said buildings to ensure fire safety compliance. Ms. Ritter instructed Ms. Linda
  Kemp to contact the board office to discuss this matter further.
