Exchange of Information/Commuity Concerns

At this time, community concerns were exchanged as follows:

Community Concern

- Ms. Anita Antonetty, representative from the Neighborhbood Advisory Board (NAB), came before the community at-large to distribute a
 "Community Needs Assessment Survey" to those in attendance. This survey is designed to perceive what services are needed within
 Community District Three.
- Ms. Joetta Brown, executive officer, stated that there is an influx of rodents in the district. Ms. Brown has requested that the community atlarge become more pro active in reporting rodent sitings to 311. She also noted that Bronx Lebanon Hospital is not a good neighbor and that the NYC Department of of Sanitation Enforcement personnel need to be more cooperative.
 - Ms.Brown informed the community at-large of the upcoming Crotona Park Running Club, Inc. 2019 New York Unity Race, a 5k Run, Walk and Jog event. This annual event will take place on Saturday, September 21st at 1700 Crotona Avenue. District Managers Report

Mr. John Dudley, district manager at Bronx Community Board Three, provided a written report. The following represents a brief summary of issues of importance affecting Bronx Community District Three:

ASS. CARL HEASTIE - NYS ASSEMBLY SPEAKER ANNOUNCEMENT

Bronx Community Board Three has received information via NY Daily News announcement today, that NYC will announce Tuesday, city administration plans to no longer issue homeowners in NYC, violations for defective sidewalk conditions due to existing tree root systems. According to the article today, Ass. Carl Heastie and Mayor Bill de Blasio reached a consensus to address the increasing backlog of issues regarding sidewalks affected and damaged by tree root systems, and agreed that going forward, NYC and not homeowners, will be responsible for fixing the conditions.

In brief, under this agreement, homeowners of one, two or three family homes, where sidewalks are damaged solely by city trees, will not receive notices of violations or liens. According to the report, officials plan to fast track repairs at 5, 500 priority sites where roots have buckled or upended sidewalks and review another roughly 50,000 existing violations to determine whether the city is responsible, and cancel the lien for any that meet the criteria.

The report notes that the city will expedite the evaluation if any homeowner is selling or re-financing his home. Additional information will be made available pending the city appouncement

BRONX COMMUNITY BOARD THREE DISTRICT SERVICE CABINET MEETINGS

Bronx Community Board Three holds regular monthly closed meetings with various city agency representatives to provide status updates on numerous requests submitted for service or maintenance related matters affecting Bronx Community District Three. All NYC agencies (NYPD, DOB, DOT, PARKS, etc.) are obligated under the NYC Charter, to attend and respond to such concerns. Board members are encouraged to communicate any service delivery concerns by calling 311 or going online to <u>www.nyc.gov</u>, and obtain a complaint reference number. This information should be forwarded via email, to the district board office at <u>jdudley@cb.nyc.gov</u> or eritter@cb.nyc.gov, for inclusion on the district service cabinet agenda.

BRONX BOROUGH CONSULTATON MEETINGS

The 2019 Bronx Borough Consultation meetings with all city agencies will be held with the Bronx Community Boards during the month of September 2019. These meetings are attended by the district manager and serve as the framework for discussion of the FY' 2021 NYC Budget related to various city agency programs and services for the Bronx and NYC at-large. These meetings will also serve as the basis for recommendations made and adopted by the community boards in the fall, as part of the board's capital and expense budget submissions for FY' 2021.

Bronx Community Board Three anticipates approval of its FY' 2021 Capital and Expense budget requests in October/November 2019. Communication will be made with all board members and the general public, to identify new budget priorities for consideration by the board at that time.

SOUTHERN BOULEVARD NEIGHBORHOOD STUDY

Bronx Community Board Three has met with the NYC Department of City Planning in August 2019 to discuss issues involving affordable housing in the Southern Boulevard Study area. This meeting was attended by representatives of HPD and DCP, and focused on a discussion of What is Affordable Housing?, Neighborhood Demographics, Current Housing Conditions in Bronx Community District Three and Housing Preservation Strategies.

The district manager will share the report with members of the Housing, Land-Use and Economic Development committee in September 2019, and subsequently the board as the study develops in the future.

SOUTHERN BOULEVARD DDC CAPITAL PROJECT #HED553

The NYC Department of Design and Construction issued its final 2019 newsletter regarding the above capital project which relates to the installation of trunk and distribution water mains along Southern Boulevard between Crotona Park East and Westchester Avenue; Boston Road between E. 179 St. and E. Tremont Avenue; E. Tremont Avenue between Boston Road and Bronx St. This project also includes combined sewer replacement, installation of new catch basins, new curbs, new sidewalks, street lighting and traffic signal work. The anticipated date of completion of the project is scheduled for August 2019.

Work which has been completed includes the installation of new 8", 12" and 20" distribution mains and well as 36" and 48" trunk mains on Southern Boulevard within the project limits of Southern Boulevard between Crotona Park East and Westchester Avenue. The scope of this project also included installation of combined sewers and new sidewalks and curbs, street lighting and intersection redesign work within the project limits.

At the request of Bronx Community Board Three, a new phase of work will be added to the Southern Boulevard project by NYC DOT. This phase will reconfigure traffic lanes as well as improve pedestrian islands and sidewalks at the intersections of Boston Road, Southern Boulevard, E. 174 St. and on Louis Nine Boulevard, Freeman St. and Southern Boulevard. This phase will commence early 2019 and will result in pedestrian safety and traffic flow enhancements at these busy intersections.

DDC is currently monitoring the final phase of the work related to asphalt installation at various point along Southern Boulevard between E. 174 St. and Westchester Avenue.
