- What are the parameters of the board to approve/deny the applications?
 - There is no specific date to close the window for license applications. About 2k applications already
- Are there any guidelines to follow (how do we decide if we should say yes/ say no)
 - Tapia: CB role is to make recommendations. Go to OCM website for guidance. First time applications open, requirements were so strict (required that people were formerly justice-involved).
- Conversation is not going anywhere as many members haven't read OCM guidelines
