**TRAFFIC & TRANSPORTATION COMMITTEE MINUTES**  
**April 9<sup>th</sup>, 2008**

Meeting was held at: Community 229-A E. 204th St., Bronx, New York 10458

Meeting Began: 7:30 PM

**I) Grand Concourse and East 204th Street Request for Parking Changes:**

A) Dr. Tamir Shadian from the 204 Medical Plaza made a request for an ambulance / "access-a-ride" parking zone in front of the 204th street side entrance of 3130 Grand Concourse. The Committee reviewed the site and proposes the following motion for consideration to the Board:

- 1) "Community Board 7 approves the request for a no parking zone between the hours of 8:00 am to 6:00 pm, except Sundays, for the 204 Medical Plaza located at the 204<sup>th</sup> Street entrance of 3130 Grand Concourse. This site would be an approximately 35 feet zone in front of the entrance for the purpose of dropping off and pick-up only." The streetlights on East 204th street that are not working will be reported.

**II) Library Lane:**

A) Ms. Rosanna Viera from the Fordham Bedford Housing Corporation came and talked about the Library Lane project. This is the name of the project that would redo Coles Lane, which is located near the Bronx Library Center. The Committee decided to make the following request to the Board:

- 1) "The Traffic and Transportation Committee of Community Board 7 strongly recommends that the Library Lane project (Cole Lane) be made a Community Board Capital Budget request for fiscal year 2010." (The Community Board Office has copies of the proposed project.

**III) Senior Walkways:**

A) The City is working on an education project for seniors in areas of the city with high senior pedestrian fatalities.

**IV) Old Business:**

A) Loring Place/140 West Fordham Road:

- 1) Various City Departments have looked at this site and issued multiple violations. The District Manager is following up on this matter.
