# **REMARKS FROM THE CHAIRPERSON – Richard Flateau**

Chair Flateau read the agenda into the record followed by his report.

He reported on the following:

• Chair Flateau informed the members that on June 3<sup>rd</sup>, he learned that Amour Cabaret was planning a Grand Opening. He sent a letter to the Chairman of the State Liquor Authority and all the elected officials asking for the immediate revocation of their license.

He reiterated that the deadline for Local Law 152 requires homeowners in Community District 1, 3 and 10 Citywide to have their gas lines inspected by a Master Plumber by June 30, 2021. This is for multidwelling homes and houses of worship.

- At the Borough Board meeting on June 1<sup>st</sup>, there was a vote on the Zoning Accessibility Tax Amendment. This amendment will give a bonus to homeowners whose properties are adjacent to subway stations.
- The vote on the Fresh Food Market and the Fitness was put on hold
- There was a vote on Capital Project for the Litchfield Villa
- On May 6<sup>th</sup>, there was a Candidate Forum held at Restoration at 6:30 p.m., which focused on economic recovery and small business development

#### Hon, Hakeem Jeffries

Congressman Jeffries discussed the American Rescue Plan. He informed that rental relief will be given for 12 months plus three additional. Applications are available for rent assistance by calling 311 or at the Office of Temporary Disability Assistance www.otda.ny.gov/erap

He added, homeowners will also be reimbursed through the Department of Homes and Community Renewal. \$9,000 per family member up to 4 members.

The Enhanced Child Tax Credit will give \$300.00 per child for children 5 years and under and \$250.00.

# ASSISTANT DISTRICT MANAGER'S REPORT

- On May 11<sup>th</sup>, I attended the Borough Service Cabinet Meeting where there was a presentation by DOT on the Neighborhood Loading Zone Program. This program is from narrow residential street that are one-way and 35ft. This is already in the following neighborhoods: 6 in Williamsburg, 10 in Park Slope and 8 in Sunset Park. There will be NO PARKING: Monday Friday 7:00 a.m. 7:00 p.m. It will decrease double parking by 10% -12%. Passenger pickup and drop off and goods delivery will be allowed.
- There was also a presentation on NYC Streets Plan. Speaker Johnson passed Local Law 195 in 2019 which says that DOT is required to complete all work such as installing protected bus and bike lanes, bus stop upgrades, pedestrian ramp and signal upgrade, and transit signal priority intersections by December 2021. In addition, there will be other road resurfacing and bridge maintenance work.

City Planning will give a presentation on CEQR-21DCP111Y, ULURP #C210351ZMM, N2103527RM, C210353ZSM – Citywide Hotels Special Permit Application for Zoning Doris Pinn, Committee Chair introduced Jesse Hirakawa, Borough Planner & Alexander Plackis

Jesse Hirakawa stated that in the last five years there have been a 40% increase in hotels. In 2018 special permits in manufacturing districts (M1) which created a consistent framing. It will only apply to high density areas that already have special permits. The following are locations in the district: Broadway, Fulton Street

# B. Housing & Land Use Committee

**IN THE MATTER OF** an application submitted by BRP East Brooklyn Development LLC pursuant to Sections 197-c and 201 of the New York City Charter for an amendment to the Zoning Map, Section No. 17a:

- changing from an R7A District to an R8A District property bounded by Dekalb Avenue, Nostrand Avenue, Kosciuszko Street, and a line 240 feet westerly of Nostrand Avenue; and
- 2. establishing within the proposed R8A District a C2-4 District bounded by Dekalb Avenue, Nostrand Avenue, Kosciuszko Street, a line 100 feet westerly of Nostrand Avenue, a line midway between Dekalb Avenue and Kosciuszko Street and a line 240 feet westerly of Nostrand Avenue;

Doris Pinn, Committee Chair introduced Meredith Marshall, Managing Partner, BRP who introduced Mary Serafy and Zachary Schwanback.

He stated that BRP East Brooklyn development LLC is a 100% Black -owned. He has developed several properties in the community: the Garvey, the Bradford, 27 Albany Avenue, and 1320 Fulton Street.

270 Nostrand Avenue will have a total of 487 units, 144 units will be at 30%. It will consist of studios and 2-bedrooms. 20,000 sq. ft will be for retail with 5,000 retail space for MWBE at below market rate. This is not City-owned land therefore, no subsidy is needed.

The project is currently 9-story however, they are proposing 14-story, 10-stories based height with 4-story setback. It is a R7A and is proposing a R8A with a commercial overlay.
