# **REMARKS FROM THE CHAIRPERSON – Richard Flateau**

Mr. Flateau reported that there was fire on Jefferson Avenue between Stuyvesant and Malcolm X Blvd in the early hours of the morning. Three homes were destroyed and some fire fighters were injured.

He gave an update on the issue of an illegal conversion at 529 Monroe Street. He also reported on the Borough Board meeting.

In response to the postal service complaints, the Board is planning a Town Hall with Congressman Jeffries.

He read the agenda into the record.

# **ACKNOWLEDGMENT OF ELECTED OFFICIALS & COMMUNITY PARTNERS**

# Gordon Bell - Bedford Stuyvesant Restoration Corp.

Mr. Bell informed the audience about the Weatherization Assistance Program. The program provide windows, insulations and LED lighting. He added that Restoration has started a new Strategic Plan and they need feedback from the community before it is finalized.

#### Hon. Scott Stringer

Comptroller Stringer informed the audience that the City has over 1,100 vacant land, 566 in Brooklyn which needs to be developed for affordable housing plan. However, the City is not creating the affordable housing for people who live in the community. 56% of the residents in East New York cannot afford the affordable housing and the developers receive incentives to build some affordable units. The Comptroller stated that we need an Affordable Housing Plan that keeps the people in the neighborhood in their homes.

He added that he is also working with community based organizations to create an opt-in program to allow New Yorkers to use their rent payments to build their credit score. It is in its pilot stage. Anyone interested in getting more information can contact the Comptroller's office. His office will make a presentation at our future meetings.

# Emily Mateo – Assembly Member Walter Mosley

Assembly Member Mosley thanked everyone who attended the State of the District. Parking calendars were also provided.

# Kathleen Daniel - Borough President Eric Adams

Borough President Adams convened a meeting after the Parkland incident with several students and they are requesting a Bill of Rights, they asked for the voting age to be lowered and they asked how to be civically engaged. On March  $14^{th}$ , the National School Walkout, there will be a rally after school from 2:00 - 5:00 p.m. in Prospect Park. Buses will be available for students to Washington on March  $24^{th}$ .

**Marcus Harris** added that March is Colon Cancer Awareness Month. Borough President Adams has partnered with ten hospitals in Brooklyn to perform screenings for uninsured clients.

Mr. Butler added that someone claiming to be a Con Ed worker tried to gain access to his neighbor's house and threatened to charge her a \$100 fee if she didn't give access. He advised everyone to aware.

## I. PUBLIC HEARING

# A. Capital & Expense Budget Committee:

The Budget Coordinator held a public hearing on the Mayor's Preliminary Budget for Fiscal Year 2019

Richard Flateau, Board Chair introduced TJ Wilson, Budget Coordinator

Ms. Wilson gave a brief review of the agency responses to the Board's Capital and Expense Budget Requests for FY 2019.

She highlighted the sanitation garage and the Sumner Armory and stated that she will be working with the committees on these items.

# **Questions & Answers**

**Simone Pratt:** Is the request for the Sumner Armory for the homeless shelter of community use?

**TJ Wilson:** It is for both, it is currently being used as a homeless shelter but the community board is trying to use it as a recreational facility also.

#### B. Parks, Arts & Culture Committee:

NYC Department of Parks & Recreation Capital Design presented on the CPI Capital Improvement of Lewis Avenue Playground located at Willoughby and Lewis Avenues *TJ Wilson, Committee Vice-Chair introduced Susan Jainchill, MKW & Associates* 

Ms. Jainchill gave a PowerPoint presentation on the proposed design for the Lewis Avenue Playground. She stated that MKW & Associate is a Landscape and Architecture Firm. They are consultants for the NYC Department of Parks & Recreation. She stated that the playground is 1.6 acres which is relatively small. The goal is to provide active recreation for different age groups, they will add equipment for the younger age group, picnic tables, improving the seating, increasing green space, adding a fountain and replacing and upgrading existing materials. The cost of the project is \$1.4 million budget. The firm also renovated the Jesse Owens and Stockton Playgrounds.

Ms. Jainchill added that the space is very symmetrical. The 7 feet wall is creating a safety issue. There are two ramps and blue stone on the sidewalk. Many of the trees will stay. In addition, she stated that a scope meeting on October 23<sup>rd</sup>, was held in which they received ideas from the community. Nothing everything that was suggested will be installed

however, some children asked for a pollinator garden. New safety surface will be added also.

## **Questions & Answers**

**Jamella Swift:** Will the playground be locked?

Ronald Taylor: It will be accessible and we will collaborate with NYPD to determine if

it needs to be lock.

**Juliana Pinto:** Will there be a bathroom?

**Susan Jainchill:** The space is too small to accommodate a bathroom.

**Richard Flateau:** When will the project start and the duration?

Susan Jainchill: It is still in the design phase, construction will begin next spring and the

project will last for a year.

**Suzette Sheppard:** Do you plan to keep the blue stones?

Susan Jainchill: The stones at the sidewalk will be kept, inside it will be removed.

TJ Wilson: Where are the blue stones going?

**Susan Jainchill:** The blue stone was an issue and deemed problematic and costly. The contractor has to dispose of it.

C. Lee Ann Woodriffe is requesting a letter of support to co-name Jefferson Avenue and Claver Place to Edwin R. Woodriffe Blvd

TJ Wilson, Committee Co-Chair introduced Lee Ann Woodriffe, Daughter

Ms. Woodriffe gave a brief history of her father's life growing up in Brooklyn before becoming a FBI agent until his death. Several family members, FBI agents, friends and FBI Explorers were in attendance.

Suggestion that the co-naming be Edwin R. Woodriffe Way rather than Blvd since the street is very narrow and a Blvd is usually very wide.

Lee Ann Woodriffe: It can be named anything as long as it is co-named for her father.

# **D.** Economic Development Committee:

Alcohol Beverage Control License Application request for a letter of support by King of the Sea Restaurant Inc., 1102 Bedford Avenue between Quincy Street & Lexington Avenue.

Keith Forest, Committee Vice-Chair introduced Marc Jean-Pierre and McKenson Cadet, Owners

Mr. Jean-Pierre stated that he and his partner met in college and has a clothing line and a boutique on Snyder Avenue in Brooklyn. They are venturing to open King of the Sea which will be a seafood restaurant not a bar. They will be serving a Cajun style broil seafood. They also have a brick oven and will be serving pizza. They have 15 years of

experience. The space has three egresses. They have a very unique drink menu which will set them apart from other restaurants.

They will hire from within the community. There will be security. The capacity is for 65 people.

**Babatunde Akowe:** Did you get support from the block association? **Marc Jean-Pierre:** We have 25 letters, 2 letters from two businesses.

**Felicia Alexander:** What will set you apart from other business?

Marc Jean-Pierre: We are not a bar and we plan on staying open based on how the community receives us.

**Simone Pratt:** What are your hours and pricing?

**Marc Jean-Pierre:** Thursdays – Sunday: 4:00 p.m. 11:00 p.m.; Fridays – Saturday: 4:00 p.m. – 2:00 a.m. The price is competitive from \$12.00 - \$25.00.

E. Alcohol Beverage Control License Application request for a letter of support by 151 Tompkins Avenue LLC, 151 Tompkins Avenue between Willoughby Avenue & Hart Street

Keith Forest, Committee Vice-Chair introduced James Freeman, Owner

Mr. Freeman stated that he has two other businesses: Sally Roots and Sweet Science in Williamsburg and Bushwick. He lives on Marion Street in Bedford Stuyvesant and would love to have a business in his neighborhood. He has a 10-year lease at Sally Roots and a 5-year lease at Sweet Science. He signed a 15-year lease at 151 Thompkins LLC.

This is a Caribbean American Barbecue. The hours of operation will be Sunday – Wednesday 12:00 p.m. – 1:00 a.m.; Thursday – Saturday until 3:00 a.m.

He received 25 signatures and 5 recommendations.

Keith Forest, Committee Vice-Chair introduced David Hurtado, Owner

Oma Holloway recused herself from the vote on the request because Calaca of Bk is part of a program at Bridge Street Development.

Mr. Hurtado introduced his wife stated that this is an existing restaurant however, he is changing the name because his partner moved to Canada. It is a Mexican Restaurant. He

has 15 years of experience. His wife is the chef plus he will one cook. The capacity of the building is for 22 people with five tables. Hours of operations are Wednesdays to Sundays from 5:00 - 10:00 p.m. The space is only 365 sq., ft.

The price of the tacos are \$3.50, quesadillas are \$6.00. He will only be serving tequila and mescal. He has the support of the block association and the community.

His wife added that there are no basement or storage area. Therefore, all food is prepared daily from scratch. She will be serving traditional Mexican dishes.

G. Alcohol Beverage Control License Application request for a letter of support by 1313 Entertainment Avenue located at the corner of New York & Atlantic Avenues *Keith Forest, Committee Vice-Chair introduced Emanuel Tropanes* 

Mr. Tropanes stated that this location is currently a hardware store. It will be opened as a bar and lounge. He is Haitian born but grew up in Brooklyn. He lived in Bed-Stuy for over 20 years. He is looking to hire 50 people from the community. He plans to open within the next five months.

The hours of operation will be 7:00 a.m. -4:00 p.m. 6 days a week; week days 6:00 p.m. -2:00 a.m. and weekends 6:00 p.m. -2:00 a.m.; and Sundays 11:00 a.m. -2:00 a.m. The space is 2000 sq. ft. Since this is a stand-alone building, he would like to add a roof top area.

**Simone Pratt:** Will this be a restaurant/bar and will there be live music? Will you have security?

**Emanuel Tropanes:** It will be a café, restaurant bar and there will be music. Yes, we will consult with a security company.

**Chinyelu Udoh:** Are you aware that there is an elementary school?

**Emanuel Tropanes:** Yes, it is on a different block.

**Orlando Ross:** Will the menu be Haitian? Will it be live music?

**Emanuel Tropanes:** It will be Caribbean based and no, it will not be live music.

**Miari Roberts:** Have you owned a business before?

**Emanuel Tropanes:** I have not owned but worked and consulted with other businesses.

Ms. Collier reported that the owner is requesting an exemption from LPC standards to legalize the replacement windows and doors which was installed in 2014-2015.

The committee recommends that LPC approved the windows on the second and third floors (above the parlor floor) because they will be less likely detract from the historic detailing of the building. The committee also recommends that LPC reject the request for exemption.
