REMARKS FROM THE CHAIRPERSON – Richard Flateau

Chair Flateau read the agenda into record. He informed the public to call in at 929-277-7040.

- Chair Flateau reported that on Friday, February 19th, Brooklyn Blooms Floral Boutique, at 1113 Fulton Street held its ribbon cutting ceremony. He presented Ms. Paris Phillips, a 29-year-old floral designer and entrepreneur with a proclamation from Borough President Eric Adams.

District Manager Butler informed that Interfaith Hospital, 1545 Atlantic Avenue have received an additional 720 vaccines however, it must be utilized by Wednesday, March 3^{rd} . They are distributing the vaccine between the hours of 7:00 a.m. - 3:00 p.m.

A. Health & Social Service Committee:

Delicia Marshall and Shalane Baker, Representatives from Gotham Health/NYC Health + Hospitals gave a report on the Gotham Health Works Initiative

Ms. Marshall stated that the Gotham Health office is located at 485 Throop Avenue. It offers Pediatrics and adult healthcare. Hours of operation are Monday to Friday 8:30 a.m. to 4:30 p.m. COVID-19 testing is being offered at the Cumberland Clinic 100 N. Portland Avenue from 8:00 a.m. to 4:00 p.m.

Ms. Baker added that they offer affordable healthcare for small business owners and their employees regardless of income or immigration status, at no cost to the employer or employee. A. Housing & Land Use Committee:

District Manager Butler gave a presentation on HPD"s Housing Connect Lottery for 1620 Fulton Street and 645 Gates Avenue affordable apartments. The Garnet is located at 1620 Fulton Street between Troy Avenue and Marcus Garvey Blvd. This is a combination of private and City owned land.

The building will be 11 stories high with 12,000 sq. ft of retail space. Some of the amenities are bike storage, shared laundry room, dishwasher, outdoor terrace, air conditioner and an on-site manager. The deadline to apply is Friday, April 9th.

645 Gates Avenue is located between Marcus Garvey Blvd and Throop Avenue. The building will be on the parking lot of the building that was not being used. It will be 89 units of low-income housing at 40% to 130% AMI. He read some of the income levels and rent for the various units. Both projects can be found on Housing Connect.
