Terms and Conditions: The above-described commercial electric clothes dryers are accepted with the following conditions:

- 1. Dryers shall be installed according to the installation instructions provided from the manufacturer.
- 2. Minimum installed clearances shall be in accordance with RS14-15 of the New York City Building Code.
- 3. Approval of all electrical equipment, apparatus, materials and devices shall be obtained from the Department's Electrical Advisory Board.
- 4. Units shall be used in compliance with the Energy Conservation Construction Code of New York State.
- 5. All shipments and deliveries of such equipment shall be provided with a metal tag, suitably placed, certifying that the equipment shipped or delivered is equivalent to that tested and accepted for use, as provided in Section 27-131 of New York City Building Code.

NOTE: In accordance with Section 27-131(d), all materials tested and accepted for use shall be subject to periodic retesting as determined by the Commissioner; and any material which upon retesting is found not to comply with Code requirements or the requirements set forth in the approval of the Commissioner shall cease to be acceptable for the use intended. During the period for such retesting, the Commissioner may require the use of such material to be restricted or discontinued if necessary to secure safety.
