I, _____, am a Master or Tower Rigger licensed by the City of New York. I have been designated as the rigger supervising the erecting, climbing, and/or dismantling of the above-referenced crane. I will be present at the job site in accordance with the rules and regulations of the City of New York and will personally verify that all horizontal bracing, collars, ties, shoring and wedges conform with the drawings approved by the Department. I will also ensure that these operations strictly follow the tower crane manufacturer's erecting, climbing and dismantling procedures. Additionally, I will comply with the Department's rules and regulations in designating a rigging foreman (Master Rigger only) and recognize that such designation does not relieve me of any responsibility for liability nor any aspects of rigging safety.

Falsification of any statement is a misdemeanor and is punishable by a fine or imprisonment, or both. It is unlawful to give to a City employee, or for a City employee to accept any benefit, monetary or otherwise, either as a gratuity for properly performing the job or in exchange for special consideration. Violation is punishable by imprisonment or fine or both. I understand that if I am found after a hearing to have knowingly or negligently made a false statement or to have knowingly or negligently falsified or allowed to be falsified any certificate, form, signed statement, application, report or certification of the correction of a violation required under the provisions of this code or of a rule of any agency, I may be barred from filing further applications or documents with the Department.
