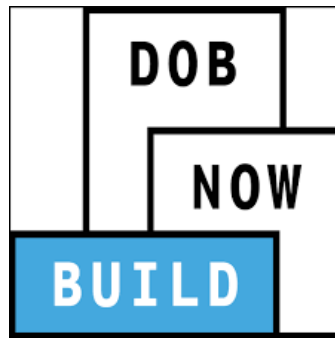

Content Overview

The purpose of information provided in this presentation is to offer an aid on how the Schedule of Occupancy module in DOB NOW should be filled out for BIS jobs.



DOB NOW: Occupancy Documents

Schedule of Occupancy

A BIS Schedule A is to be used to populate the DOB NOW Job Schedule of Occupancy (JSO) for a given BIS job



All the JSOs on a given BIN will roll up to a single building Schedule of Occupancy (BSO)



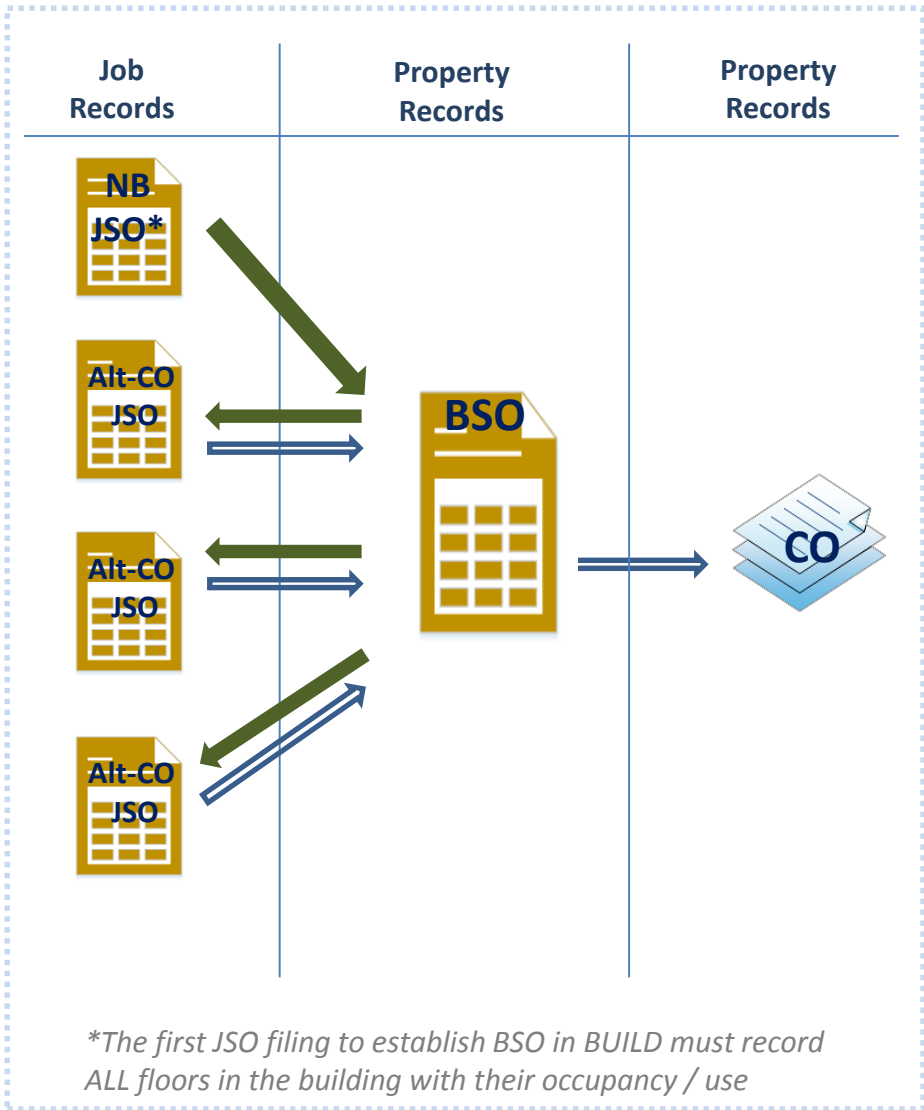
The BSO will be used to generate the Certificate of Occupancy (CO)

Certificate of Occupancy

Certificates of Occupancy will be issued only using the latest NYC Building Code Occupancy Classifications and descriptions (currently 2014 Edition)



This includes for existing buildings regardless of which Building Code the building is required to comply with (2014, 2008, 1968, or prior to 1968 Codes).



**The first JSO filing to establish BSO in BUILD must record ALL floors in the building with their occupancy / use*

When to enter 'Existing' Information

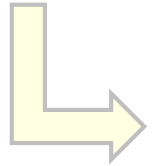


When the space is inspected and established on records



What does "established on records" mean?

Confirmed on CO/TCO records
or
No CO/TCO but supported by other records




DOB Plan Examiners

a) IF The populated record conforms to a TCO/CO THEN Examiner sets status to "Verified"

b) IF The populated record does not conform to a TCO/CO but was accepted on the BIS job THEN Examiner sets status to "Unverified"

c) IF The record has both Existing and Proposed entered THEN Examiner sets status to "Active"

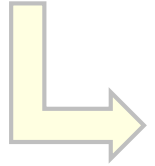
When to enter 'Proposed' Information



When the space is being constructed or altered but is not yet inspected and occupied



All proposed floor/use must be entered using 2014 occupancy classification




DOB Plan Examiners

IF BIS job confirms the scope is included THEN Examiner sets status to "Active"

DOB NOW: Schedule of Occupancy

The following strategies demonstrate how a floor/use record within the job Schedule of Occupancy (JSO) should be filled out, based on the Certificate of Occupancy situation:

NB Job Filed – Scenarios

NB-1. No occupancy was previously issued in BIS

NB-2. Core & Shell issued in BIS

NB-3. Core & Shell was issued in BIS and PAA filed in BIS after Core & Shell was issued

NB-4. Temporary CO was issued in BIS

Alt1 Job Filed where BIN Already Has Final CO – Scenarios

A1-1. An Alt1 with Enlargement is filed in BIS. No occupancy issued on the given job.

A1-2. An Alt1 with Enlargement is filed in BIS. A TCO was issued on the given job.

A1-3. An Alt1 job is filed in BIS to **change the use** for a portion of the building – no occupancy has been issued for that Alt1 in BIS.

A1-4. An Alt1 job is filed in BIS to **change the use** for a portion of the building – occupancy has been issued for that Alt1 in BIS.

A1-5. An Alt1 job is filed in BIS (with **no change in use**) for a portion of the building – no occupancy has been issued for that Alt1 in BIS.

A1-6. An Alt1 job is filed in BIS (with **no change in use**) for a portion of the building – occupancy has been issued for that Alt1 in BIS.

Alt1 Job Filed where BIN Has No CO – Scenarios

A1-7. No prior occupancy was issued in BIS on the space and no TCO issued on the given job.

A1-8. Evidence of occupancy via something other than a Certificate of Occupancy (pre-1938 building).*

Important Considerations

1. Applicants shall not record floor level restrictions/exceptions on the JSO for existing or proposed spaces.



DOB Project Advocate will add such information when they review the eventual CO request.

2. The 'Borough Comments' that get populated onto the CO document are entered by DOB personnel only.

-
3. The 'CofO Comments' shall be added by the applicant on the JSO application if they are already present on the existing BIS Schedule A or BIS Final CO.



Do not add new CofO comments that are not previously shown on the approved BIS Schedule A.

-
4. The JSO is for the transfer of Schedule A information into DOB NOW only.



If the existing BIS Schedule A is flawed, it must be corrected with a PAA in BIS prior to populating the JSO in DOB NOW.
