Department of Environmental Protection

The Department of Environmental Protection (DEP) will prepare a list of non-certified asbestos investigators and forward a copy of the ACP forms which indicate job number and the investigator's name to the Assistant Commissioner of Operations.

The Assistant Commissioner of Operations will take action on the non-certified Asbestos Investigators, by revoking the permits for the jobs they have filed.

Collection of Fees from Non Mayoral Agencies

At the present time, DEP has asked that the Department of Buildings not collect fees from Mayoral agencies. Not-for-profit organizations and non-mayoral agencies should pay the DEP fee. An issue has arisen with respect to the Housing Authority and its exemption from fees under Section 52(1) of the Public Housing Law. Until instructed otherwise, no fee shall be required from the Housing Authority.
