**ADVISORY: Civilian Complaint Review Board to Hold Community Board Meeting in Queens**

**New York, NY** – The Civilian Complaint Review Board (CCRB) will hold its monthly Board Meeting at Queens Library at Long Island City on Wednesday, January 10, 2018 at 6:30 p.m.

Community members, advocates, the Board and commanding officers from area precincts will be present to discuss police-community relations in Queens. During this first meeting since the City Council passed the Right to Know Act, the Board will address the legislation and the impact its enactment will have on police-civilian interactions and Agency operations.

The CCRB welcomes all New Yorkers to share their experiences with police-community relations. Agency investigators will be present to receive complaints of police misconduct.
