### 2016

#### A Note on Methodology and Data Discrepancies

Data for previous years in this Annual Report may differ slightly from the numbers in the prior Annual Report. This is because complaint data is subject to change during the course of an investigation. For example, an allegation may be included in the early part of the investigation and then not pleaded after a closer look at the evidence. Therefore, numbers run from the CCRB database at one point in time may slightly differ from numbers run from another point in time. Rather than reusing the counts published in prior years, we have updated all counts to provide you with the most up to date data.

Please note: regarding the number of allegations received in 2016, the data presented herein differs slightly from the data presented in the *2016 Annual Report* itself. As discussed above, this is because the number of allegations included in an open complaint is often adjusted as the complaint is investigated and before it is closed. Therefore, the total number of allegations in the database can change depending on when the database is queried. Data in the *2016 Annual Report* was finalized in June, 2017. The data presented here in the *2016 Annual Report Appendix* was finalized in July, 2017. Consequently, the *2016 Annual Report Appendix* shows fewer allegations received in 2016 than did the *2016 Annual Report*.
