

EXECUTIVE DIRECTOR'S REPORT JANUARY 2013

January's statistical report contains data on October, November and December, plus a preliminary look at 12-month/year-end statistics.

Under normal circumstances, there would have been separate reports for each of those months. However, when Hurricane Sandy struck on October 29, 2012, it flooded CCRB's building and destroyed electrical wiring. From that point until December 22nd, the CCRB could not access data in its Complaint Tracking system, from which the monthly statistical analyses are derived.

Important Note re: November and December Intake Numbers:

The CCRB's phone system was also destroyed by the hurricane and the toll-free 800 # used for complaint intake became inoperative. Despite having a 212 replacement # that has been operational since November 7th, there was a precipitous drop in the number of complaints filed by phone in November and December. This contributed to a large drop in total complaint intake for those 2 months.

Specifically, in the month of October before the hurricane, 82% of complaints filed directly with the CCRB were filed by phone. After Sandy, about one-third of all complaints filed with the CCRB directly were filed by phone.

Before the hurricane, intake increased by 30% in October 2012 compared to October 2011. This was the fourth straight month of increases. In November, complaints were down 33% compared to November of 2011 and down 22% in December, compared to December 2011.

Since November 7th when CCRB established the 212 intake phone, the city's 311 service has been giving out this number to callers. However, before Hurricane Sandy, callers to 311 would be transferred directly to the CCRB and didn't have to make a second phone call. This also appears to be a factor in the sharp decrease in complaints received in November and December.
