What is the Key to NYC?

Key to NYC is a key part of New York City's historic effort to encourage New Yorkers to get vaccinated. demonstrate that you received one dose of a vaccine authorized by the United States Food and Drug Administration or by the World Health Organization. We want New Yorkers to have fun and experience all the amazing things this city has to offer, but to do so safely by being vaccinated.

What do I need to know before I go to a restaurant or gym?

Make sure you have proof of vaccination! This can be your paper vaccination card or a picture of your card, the NYC COVID Safe App or Excelsior Pass. Also, you will need identification with your name and date of birth or name and photo to verify it matches your proof of vaccination. This can be a driver's license, IDNYC, school ID, pass-
