- Disponiblite pou telechaje lojisyèl konferans videyo sekirize (pou Preparasyon Taks Vityèl)



Idantifikasyon

- Pyès idantite ki gen foto leta bay (IDNYC ladan)
- Kat Sekirite Sosyal oswa Lèt detèminasyon Nimewo Idantifikasyon Kontribiyab Endividyèl (ITIN) (orijinal, kopi, oswa dokiman elektwonik) ak dat nesans pou oumenm, mari/madanm ou ak depandan ou yo



Prè Revni

- Fòm W-2, 1098, 1099, oswa dosye revni ak depans si ou se yon travayè endepandan (Ale nan nyc.gov/taxprep pou jwenn yon lis.)



Lòt

- Deklarasyon taks sou revni oswa relve taks pou 2018 (si yo disponib)
Pou mande yon relve, rele Sèvis Revni Entèn (Internal Revenue Service, IRS) nan 1-800-908-9946 oswa ale nan irs.gov epi chèche "Get Transcript" (jwenn yon relve).
- Prè pwoteksyon asirans sante oswa Sètifika Egzanpsyon Asirans Sante pou oumenm, mari/madanm ou, ak depandan ou yo
- Dosye peman pou gadri timoun, ki gen ladan non, adrès founisè a, ak Nimewo Idantifikasyon Anplwayè (Employer Identification Number), Nimewo Idantifikasyon Kontribiyab (Taxpayer Identification Number), oswa nimewo Sekirite Sosyal
- Dosye depans pou edikasyon tankou Fòm 1098-T pou peman ekolaj pou ale nan yon inivèsite oswa kolèj teknik oswa Fòm 1098-E si ou peye enterè prè etidyan

Tax Day is **July 15, 2020**. If you didn't file yet, there are two ways you can file for free from the safety of home.



Virtual Tax Prep

Must earn \$64,000 or less (families)
or \$45,000 or less (single filer).

Use a secure video conference and digital system to give information to an IRS certified VITA/TCE volunteer preparer who will prepare your taxes for you.



Assisted Self-Prep

Must earn \$69,000 or less.

Use free tax filing software to do your own taxes. An IRS certified VITA/TCE volunteer preparer will be available by phone or email to answer your questions.

What you need to file:

- Access to a computer, tablet, or smartphone
- A stable internet connection
- Email address
- Your 2018 Adjusted Gross Income (AGI) or self select PIN (for Assisted Self-Prep)
- The ability to download secure video conference software (for Virtual Tax Prep)



Identification

- Government-issued photo ID (includes IDNYC)
- Social Security cards or Individual Taxpayer Identification Number determination letters (original, copy, or electronic document) and birth dates for you, your spouse, and your dependents



Proof of Income

- Forms W-2, 1098, 1099, or income and expense records if you are self-employed (Go to nyc.gov/taxprep for a list.)



Other

- 2018 tax return or transcript (if available)
To request a transcript, call the Internal Revenue Service (IRS) at 1-800-908-9946 or visit irs.gov and search "Get Transcript."
- Proof of health insurance coverage or Health Insurance Exemption Certificate for you, your spouse, and your dependents
- Payment records for child care, including the provider's name, address, and Employer Identification Number, Taxpayer Identification Number, or Social Security number
- Records of educational expenses such as Form 1098-T for tuition payments to attend a university or technical college or Form 1098-E if you paid student loan interest
- Account and routing numbers for direct deposit of your refund

If you are filing a joint return, both spouses must sign.
