- MA1s are Master Agreements / Requirements Contracts, which are multi-year agreements for an indefinite quantity of goods to be furnished on an as-ordered basis at prices established in the contract.

- CT1s are one-time contracts for the delivery of a specific quantity of goods within a specified time frame, or a contract that includes a provision that allows the City to order an additional (predetermined) percentage of goods covered by the contract.
