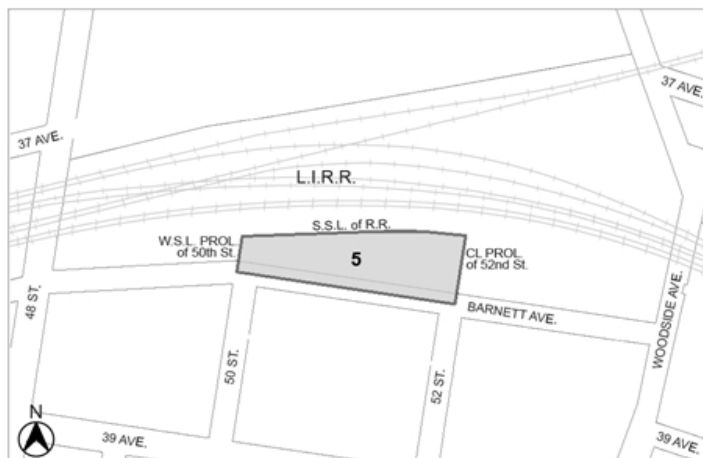

In addition, with Tenant's first payment, Tenant to pay Landlord a one-time lump sum payment equal to the difference in rent paid by Tenant under the existing lease and the rent under the new lease; calculated as (a) \$17,135.50/month x (b) the number of months from July 1, 2016 to lease execution.

The lease may be terminated in whole, by the Tenant at the end of five (5) years following Substantial Completion, or at any time thereafter; provided the Tenant gives the Landlord 365 days' prior written notice. The Landlord shall prepare final architectural plans and engineering plans and make alterations and improvements in accordance with specifications which are attached to the lease. The alterations and improvements consist of Base Building Work, which the landlord shall provide at its sole cost and expense, and Tenant Work. The total cost of the Tenant Work, which includes the cost of final architectural plans and engineering plans for the Tenant Work shall not exceed \$999,682.10. The Tenant shall reimburse the Landlord for Tenant's work, to be disbursed upon the substantial completion of the alterations and improvements.
