***Editor's Note re: Attendance for the Stated Meeting held on June 13, 2019, the Recessed Meeting held on June 18, 2019, and the brief procedural Recessed Meeting held on June 19, 2019: The Recessed Meetings held on June 18, 2019 and June 19, 2019, are considered to be the continuation and conclusion of the Stated Meeting which opened on June 13, 2019. For attendance purposes, therefore, any Council Member who was present at any one of these three Meetings will be considered present for all of the proceedings known collectively as the Stated Meeting of June 13, 2019. Although the Council Members Barron, Deutsch, Espinal, Gibson, King, Miller, Moya, Perkins, Powers, and Torres were absent from this Recessed Meeting, they are considered Present but Not Voting for these June 19th proceedings due to their earlier presence at the Stated Meeting held on June 13, 2019. Council Member Lancman is considered absent since he was not marked present for any of the aforementioned three meetings.*

(On a separate note: although not listed in the above Roll Call, it should be noted that the following Council Members were marked present for the subsequent Roll Call held for the Stated Meeting of June 19, 2019 which opened immediately following the adjournment of this brief procedural Recessed Meeting: Council Members Barron, Deutsch, Espinal, Gibson, King, Lancman, Miller, Moya, Perkins, Powers, and Torres; Council Member Levin, considered on Paternity Leave (and who did not answer the Roll Call for this Recessed Meeting), chose to attend the subsequent Stated Meeting of June 19, 2019 and cast his vote for the items before the Council)

Whereupon on motion of the Speaker (Council Member Johnson), the Public Advocate (Mr. Williams) adjourned these proceedings to meet immediately again for the Stated Meeting of June 19, 2019.

Editor's Local Law Note: Int. Nos. 59-A, 551-A, 562-A, 975-A, 977-A, 1107-A, 1171-A, 1241-A, 1242-A, 1247-A, 1257-A, 1258-A, 1274-A, 1275-A, 1277-A, 1278-A, 1279-A, 1280-A, and 1533-A, all adopted at the May 8, 2019 Stated Meeting, were returned unsigned by the Mayor on June 11, 2019. These items become law on June 8, 2019 due to the lack of Mayoral action within the Charter-prescribed thirty day time period. These bills were assigned subsequently as Local Laws Nos. 101 through 119 of 2019, respectively.
