WHAT THE JOB INVOLVES:

Public Health Educators, under general supervision, identify community health information needs and develop, organize, conduct, and evaluate health education programs to meet those needs. All Public Health Educators perform related work.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

THE SALARY:

The current minimum salary is \$49,900 per annum. This rate is subject to change. There are three assignment levels within this class of positions. Appointments will generally be made to Assignment Level I. After appointment, employees may be assigned to the higher assignment level at the discretion of the agency.

HOW TO QUALIFY:

You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you may not receive a score.

You will **not** receive credit for education which you obtain after June 30, 2019 or experience which you obtain after the end of the Application Period (March 26, 2019).

EDUCATION AND EXPERIENCE REQUIREMENTS:

- (1) A baccalaureate degree from an accredited college or university **and** two years of full-time satisfactory experience in: (a) developing public health education programs, including identifying target populations, conducting needs assessments, designing educational materials, planning educational presentations or workshops, and evaluating health education programs; (b) presenting public health education programs; and/or (c) counseling in areas such as communicable diseases, substance abuse, assault, sexual abuse, and/or family planning; **or**
- (2) A master's degree from an accredited college or university in one of the following areas: public health education, education, public/community health administration, public administration or business administration **and** one year of full-time satisfactory experience as described in "1" above.

The education requirement must be met by June 30, 2019. The experience requirement must be met by the last day of the Application Period (March 26, 2019).

The college or university must be accredited by regional, national, professional, or specialized agencies recognized as accrediting bodies by the U.S. Secretary of Education and by the Council for Higher Education Accreditation (CHEA).

If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. This is required only if you need credit for your foreign education in this examination. For more information see the Foreign Education Evaluation Guide in the Required Information section.

You have until midnight Eastern time on the last day of the Application Period (March 26, 2019) to clearly specify in detail all of your relevant education and experience on your Education and Experience Test and submit it in the Online Application System (OASys). Once you submit your Education and Experience Test in OASys, you will not be permitted to submit new or additional information about your education and/or experience online.

You will not receive credit for education which you obtain after June 30, 2019 or experience which you obtain after the end of the Application Period (March 26, 2019).

READ CAREFULLY AND SAVE FOR FUTURE REFERENCE

Residency Requirement: Under New York City Administrative Code Section 12-120, you might need to be a resident of the City of New York within 90 days of the date you are appointed to this position. Since residency requirements vary by title, appointing agency and length of service, consult the appointing agency's personnel office at the time of the appointment interview to find out if City residency is required.

English Requirement:

You must be able to understand and be understood in English.

Proof of Identity:

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services.

HOW TO APPLY:

If you believe you meet the requirements in the "How to Qualify" section, apply using the Online Application System (OASys) at www.nyc.gov/examsforjobs. Follow the onscreen application instructions for electronically submitting your application and payment and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. All new OASys accounts require verification before a candidate can apply to ensure the accuracy of candidate information. Verification is instantaneous for most accounts and you will receive a confirmation email with instruction to activate your account. For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.

The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets. If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. Special Circumstances Guide: This guide is located on the DCAS website at www.nyc.gov/html/dcas/downloads/pdf/misc/pdf_c_special_circumstances_guide.pdf and available at the DCAS Computer-based Testing & Applications Centers. This guide gives important information about claiming Veterans' or Legacy credit, and notifying DCAS of a change in your mailing address. Follow all instructions on the Special Circumstances Guide that pertain to you when you complete your "Application for Examination."

REQUIRED INFORMATION:

- 1. Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
- 2. Education and Experience Test:** Fill out all the required sections displayed onscreen (if applicable). You will have until midnight Eastern time on the last day of the Application Period (March 26, 2019) to clearly specify in detail all of your relevant education and experience on your Education and Experience Test and submit it in the Online Application System (OASys).
- 3. Foreign Education Evaluation Guide (Required only if you need credit for your foreign education in this examination):** If you were educated outside the United States, you must have your foreign education evaluated to determine its equivalence to education obtained in the United States. The services that are approved to make this evaluation are listed on the Foreign Education Evaluation Guide which is located on the DCAS website at www.nyc.gov/html/dcas/downloads/pdf/misc/foreigneducation.pdf. When you contact the evaluation service, ask for a "document-by-document" evaluation of your foreign education. You must have one of these services submit its evaluation of your foreign education directly to the Department of Citywide Administrative Services no later than eight weeks from June 30, 2019.

THE TEST:

Your score will be determined by an education and experience test. You will receive a score of 70 points for meeting the education and experience requirements listed on page 1. After these requirements are met, you will receive additional credit up to a maximum of 100 points on the following basis:

If you have satisfactory full-time experience in developing public health education programs, including identifying target populations, conducting needs assessments, designing educational materials, planning educational presentations or workshops, and evaluating health education programs, for: **You will receive:**

At least 1 year but less than 3 years 5 points

At least 3 years but less than 5 years 10 points

5 or more years 15 points

If you have satisfactory full-time experience as a counselor in a health-related field for: **You will receive:**

At least 1 year but less than 3 years 5 points

At least 3 years but less than 5 years 10 points

5 or more years 15 points

Additional points for certification(s): **You will receive:**

Certified Health Education Specialist (CHES): 10 points

Master Certified Health Education Specialist (MCHES): 20 points

Note: You will not receive points for a certification if you do not disclose on the Education and Experience Test the issue date and certificate number.

You will receive a maximum of one year of experience credit for each year you worked. If you have any of the above experience on a part-time basis, it will be credited according to the equivalent percent of full-time experience. Each year of experience will be credited under only one category which will be the highest appropriate category. **Experience used to meet the minimum requirements cannot be used to gain additional credit.**

You have until midnight Eastern time on the last day of the Application Period (March 26, 2019) to clearly specify in detail all of your relevant education and experience on your Education and Experience Test and submit it in the Online Application System (OASys). Once you submit your Education and Experience Test in OASys, you will not be permitted to submit new or additional information about your education and/or experience online.

You will not receive credit for education which you obtain after June 30, 2019 or experience and certifications which you obtain after the end of the Application Period (March 26, 2019).

CHANGE OF NAME AND/OR SOCIAL SECURITY NUMBER:

THE TEST RESULTS:

If you pass the education and experience test, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by mail of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. ADDITIONAL INFORMATION:

Selective Certification for Foreign Language and/or American Sign Language: If you can speak Albanian, Arabic, Bengali, Bosnian/Serbo-Croatian, Chinese (Cantonese), Chinese (Mandarin), French, Greek, Haitian/Creole, Hindi, Italian, Japanese, Korean, Portuguese, Polish, Russian, Spanish, Tibetan, Urdu, Vietnamese, West African Languages (e.g., Ibo, Swahili, Yoruba), Yiddish and/or you know American Sign Language, you may be considered for appointment to positions requiring this ability through a process called Selective Certification. If you pass a qualifying test, you may be given preferred consideration for positions requiring this ability. If you wish to indicate language(s) you speak and/or know for this Selective

Certification, click on the Selective Certification option and follow the instructions by checking the appropriate selection to indicate the language(s) you speak and/or know.

Selective Certification for License, Certification and/or Special Experience: If you have the license, certification and/or experience listed in one or more of the areas listed below, you may be considered for appointment to positions requiring a license, certification and/or experience through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this license, certification and/or experience. Your license(s), certification(s) and/or experience will be checked by the appointing agency at the time of appointment.

1. **Selective Certification as a Licensed Mental Health Counselor (LMHC):** A valid license as a Licensed Mental Health Counselor (LMHC) in New York State. If you wish to apply for this Selective Certification, select "**MHC**" on your Education and Experience Test and submit it in the Online Application System (OASys). This license must be maintained for the duration of your employment.
2. **Selective Certification for Position Requiring a Masters Social Work License (LMSW):** A valid license as a Licensed Masters Social Worker (LMSW). This license must be maintained for the duration of your employment. If you wish to apply for this Selective Certification, select "**LMS**" on your Education and Experience Test and submit it in the Online Application System (OASys). This license must be maintained for the duration of your employment.
3. **Selective Certification for Certified Application Counselors:** A certified New York State of Health Certified Application Counselor. If you wish to apply for this Selective Certification, select "**CAC**" on your Education and Experience Test and submit it in the Online Application System (OASys). This license must be maintained for the duration of your employment.
4. **Selective Certification for Incident Command Structure (ICS) Certification:** A valid Incident Command Structure (ICS) certification such as FEMA's Professional Development Series certificate or an IS-100.c, IS-200.b, IS-200.HCa, IS-700.b, IS-702.a, or IS-800.c certificate. If you wish to apply for this Selective Certification, select "**ICS**" on your Education and Experience Test and submit it in the Online Application System (OASys). This license must be maintained for the duration of your employment.
5. **Selective Certification for Needs Assessment and Survey Experience:** At least two (2) years of satisfactory full-time experience conducting surveys with health care professionals (i.e. primary care providers, clinical staff, and pharmacists, etc.) to identify public health needs, problems and available resources to design health education trainings, curricula and education campaigns. If you wish to apply for this Selective Certification, select "**EAX**" on your Education and Experience Test and submit it in the Online Application System (OASys).
6. **Selective Certification for Providing Education on Smoking Cessation and Chronic Disease Management:** At least one (1) year of satisfactory full-time experience providing health education in one or more of the following public health topics: Tobacco Control, Smoking Cessation and/or Chronic Disease management. If you wish to apply for this Selective Certification, select "**TAB**" on your Education and Experience Test and submit it in the Online Application System (OASys).
7. **Selective Certification for Certain Positions in School Health:** At least one (1) year of full-time satisfactory experience working in a school or educational program, in a teaching, counseling, mentoring, social work, nursing, or therapist role. If you wish to apply for this Selective Certification, select "**SHP**" on your Education and Experience Test and submit it in the Online Application System (OASys).
8. **Selective Certification for Positions Requiring Health Program Management Experience:** At least two (2) years of post-masters degree or four (4) years post-bachelors degree satisfactory full-time supervisory experience in health program management within an educational, health or mental health care setting or institution. If you wish to apply for this Selective Certification, select "**PHP**" on your Education and Experience Test and submit it in the Online Application System (OASys).
9. **Selective Certification for Position Requiring Supervising Counseling Experience:** At least two (2) years of post-masters degree experience in a full-time supervisory position supervising subordinates who provide mental health or mental health related services including assessment, counseling, referral, psycho-education, and related services. If you wish to apply for this Selective Certification, select "**SCE**" on your Education and Experience Test and submit it in the Online Application System (OASys).
10. **Selective Certification Municipal Experience:** At least one (1) year of satisfactory, full-time experience working within a municipal government in a similar position, which provides service for a city with over 1 million in population. If you wish to apply for this Selective Certification, select "**MGE**" on your Education and Experience Test and submit it in the Online Application System (OASys).
11. **Selective Certification for Mental Health Training:** At least two (2) years of satisfactory full-time experience facilitating groups, providing training and developing curricula on mental health topics such as suicide, depression, and/or substance abuse. If you wish to apply for this Selective Certification, select "**MHT**" on your Education and Experience Test and submit it in the Online Application System (OASys).
12. **Selective Certification for Overdose Prevention:** At least two (2) years of satisfactory full-time experience providing overdose prevention trainings and education. If you wish to apply for this Selective Certification, select "**ODP**" on your Education and Experience Test and submit it in the Online Application System (OASys).
13. **Selective Certification for Providing Nutrition Services and Safety Training:** At least one (1) year of satisfactory full-time experience providing health education in public health Nutrition Services (i.e. SNAP/WIC/Farmers Market benefits; child nutrition; and/or food safety). If you wish to apply for this Selective Certification, select "**NST**" on your Education and Experience Test and submit it in the Online Application System (OASys).
14. **Selective Certification for Positions Requiring Sexual and Reproductive Health Education Experience:** At least one (1) year of satisfactory, full-time experience providing education on sexual and reproductive health topics within a health services setting, an educational program, and/or a community based organization. If you wish to apply for this Selective Certification, select "**SRH**" on your Education and Experience Test and submit it in the Online Application System (OASys).
15. **Selective Certification for Positions Requiring Experience in Asthma Specific Hands-On Training in School Health:** At least one (1) year of full-time, satisfactory experience conducting Asthma specific hands on training with school age children in a school setting and/or community center. If you wish to apply for this Selective Certification, select "**AST**" on your Education and Experience Test and submit it in the Online Application System (OASys).

16. **Selective Certification for Positions Requiring Experience with Training Applications and Systems Tools:** At least (12) months of full-time satisfactory experience working in a Public Health agency using training applications and systems tools such as: Localytics, Sysomos, PastPerfect, Extensis Portfolio, Communication Project Request System, Adobe Creative Suite and Cloud (InCopy, Photoshop, Dreamweaver and InDesign), TeamSite, Webtrends, Java, Simply Measured, Hootsuite, Facebook Business Manager and Twitter Ads. If you wish to apply for this Selective Certification, select "**TAT**" on your Education and Experience Test and submit it in the Online Application System (OASys).
17. **Selective Certification for Positions Requiring Asthma Educator Certification:** A valid Asthma Educator Certification issued by the National Asthma Educator Certification Board (NAECB). If you wish to apply for this Selective Certification, select "**AEC**" on your Education and Experience Test and submit it in the Online Application System (OASys).
18. **Selective Certification for Positions Requiring G Suite Product Usage Experience:** At least one (1) year of full-time, satisfactory experience using G Suite applications for data reporting and tracking information. If you wish to apply for this Selective Certification, select "**GPE**" on your Education and Experience Test and submit it in the Online Application System (OASys).
19. **Selective Certification for Positions Requiring Field Engagement with Digital Communication Tools Experience:** At least one (1) year of full-time, satisfactory experience utilizing digital communication tools such as tablets (Android and iOS), iPads, smart phones, Google forms/surveys, and Outlook applications to effectively report and track live and time sensitive data, providing accurate and detailed reports and follow-up workflows. If you wish to apply for this Selective Certification, select "**CDF**" on your Education and Experience Test and submit it in the Online Application System (OASys).

The above Selective Certification requirements may be met at any time during the duration of the list. If you meet the Selective Certification requirement(s) at some future date, please submit a request by mail to: DCAS Bureau of Examinations - Exam Development Group, 1 Centre Street, 14th Floor, New York, NY 10007. Please include the examination title and number, your social security number, and the Selective Certification you are requesting on your correspondence.

Application Receipt:

You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folder for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the Exam # and your Profile # located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.

PENALTY FOR MISREPRESENTATION:

Any intentional misrepresentation on the application or examination may result in disqualification, even after appointment, and may result in criminal prosecution.
