WHAT THE JOB INVOLVES:

Marine Engineers (Diesel) operate the main propulsion equipment and auxiliaries of diesel powered vessels of the City of New York. Under direction, they assist in the operation and maintenance of the engine room; assist in the maintenance, minor, or emergency repair work and operation of the main propulsion equipment, auxiliaries, electrical equipment, steering engines, pumps, and fuel tanks of diesel vessels of the City of New York; assist in the proper care, storage, and use of fuel on board ship. All Marine Engineers (Diesel) perform related work.

Special Working Conditions:

Marine Engineers (Diesel) may be required to work various shifts including nights, Saturdays, Sundays, and holidays.

Some of the physical activities performed by Marine Engineers (Diesel) and the environmental conditions experienced are: walking up and down steep gang ways, ladders, and stairs; communicating orally; requiring good vision and hearing when standing watch aboard ship; using speed and agility during shipboard emergencies; lifting equipment weighing at least 50 pounds; working outdoors in inclement weather; and working in confined areas that may be damp, dusty, dark, smoky or acrid.

(This is a brief description of what you might do in this position and does not include all the duties of this position.)

THE SALARY:

The current minimum salary for Assignment Level I is \$77,857 per annum. This rate is subject to change. There are two assignment levels within this class of positions. Appointments will generally be made to Assignment Level I. After appointment, employees may be assigned to the higher assignment level at the discretion of the agency.

HOW TO QUALIFY:

You are responsible for determining whether or not you meet the education and experience requirements for this examination prior to submitting your application. If you are found "Not Qualified," your application fee will not be refunded and you will not receive a score.

LICENSE AND CREDENTIAL REQUIREMENTS:

A valid United States Coast Guard Merchant Mariner Credential (MMC) with endorsement as a Third Assistant Engineer Unlimited, Motor Vessels, or Limited Assistant Engineer of Motor Vessels of at least 6000 H.P., or higher license. This license must be maintained for the duration of employment.

The license requirement must be met by the last day of the Application Period (August 30, 2022).

You have until midnight Eastern time on the last day of the Application Period (August 30, 2022) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (August 30, 2022), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

Transportation Worker Identification Credential (TWIC) Requirement: Within thirty days of appointment, you must possess a valid Transportation Worker Identification Credential (TWIC) issued by the U.S. Transportation Security Administration (TSA). If you are engaged in an appeal or waiver process

for the TWIC, you will not be considered for appointment until such process has been completed. The TWIC must be maintained for the duration of employment.

Medical Requirement: Medical guidelines have been established for the position of Marine Engineer (Diesel). Candidates will be examined to determine whether they can perform the essential functions of the position of Marine Engineer (Diesel). Where appropriate, a reasonable accommodation will be provided for a person with a disability to enable him or her to take the examination, and/or to perform the essential functions of the job.

Drug Screening: You must pass a drug screening in order to be appointed, and if appointed you will be subject to random drug and alcohol testing for the duration of your employment. Any Marine Engineer (Diesel) found in possession of, or using, illegal drugs will be terminated.

Residency Requirement Advisory:

Under New York City Administrative Code Section 12-120, you might need to be a resident of the City of New York within 90 days of the date you are appointed to this position. Since residency requirements vary by title, appointing agency and length of service, consult the **appointing agency's personnel office** at the time of the appointment interview to find out if City residency is required.

Vaccination Requirement:

As of August 2, 2021, all new hires must be vaccinated against the COVID-19 virus, unless they have been granted a reasonable accommodation for religion or disability. If you are offered city employment, this requirement must be met by your date of hire, unless a reasonable accommodation for exemption is received and approved by the hiring agency.

English Requirement:

You must be able to understand and be understood in English.

Proof of Identity:

Under the Immigration Reform and Control Act of 1986, you must be able to prove your identity and your right to obtain employment in the United States prior to employment with an agency under the jurisdiction of the Commissioner, Department of Citywide Administrative Services.

HOW TO APPLY:

If you believe you meet the requirements in the "How to Qualify" section, apply using the Online Application System (OASys) at www.nyc.gov/examsforjobs. Follow the onscreen application instructions for electronically submitting your application and payment and completing any required information. A unique and valid email address is required to apply online. Several internet service providers, including but not limited to Google, Yahoo!, AOL, Outlook.com, and Mail.com offer free email addresses. **All new OASys accounts require verification before a candidate can apply to ensure the accuracy of candidate information. Verification is instantaneous for most accounts and you will receive a confirmation email with instructions to activate your account. For any account creation issues, you will receive onscreen prompts to contact DCAS. This review may require up to two (2) business days to be reviewed and resolved. Please keep this information and the application period deadline in mind when creating your account.**

The following methods of payment are acceptable: major credit card, bank card associated with a bank account, or a prepaid debit card with a credit card logo which you may purchase online or at various retail outlets. If you are receiving or participating in certain forms of public assistance/benefits/programs, or are a veteran, you may qualify to have the application fee waived. You may come to the DCAS Computer-based Testing & Applications Centers to apply for this examination online. However, you must schedule a customer service appointment prior to your visit. Due to the COVID-19 pandemic, DCAS no longer permits walk-ins at DCAS sites.

You must complete the entire application by midnight, Eastern Time, of the last day of the application period. If you have questions about applying for this examination, you may contact DCAS at OASys@dcas.nyc.gov.

REQUIRED INFORMATION:

1. **Application for Examination:** Follow the online instructions, including those relating to the payment of fee and, if applicable, those found in the Special Circumstances Guide.
2. **Education and Experience Exam:** Fill out all the required sections displayed onscreen (if applicable). You will have until midnight Eastern time on the last day of the Application Period (August 30, 2022) to clearly specify in detail all of your relevant education and experience on your Education and Experience Exam and submit it in the Online Application System (OASys).

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (August 30, 2022), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this examination (if applicable), and your application fee will not be refunded.

THE TEST:

Your score will be determined by an Education and Experience Exam. You will receive a score of 70 points for meeting the license and credential requirements listed in the "How to Qualify" section. After this requirement is met, you will receive additional credit up to a maximum of 100 points on the following basis:

If you have satisfactory full-time in-harbor tanker experience while in possession of a valid license for Third Assistant Engineer, Motor Vessels, of at least 6000 H.P., or an appropriate higher level license (i.e, Second Assistant Engineer, or Chief Engineer) for: **You will receive up to:**

At least 2 years but less than 4 years	6 points
At least 4 years but less than 6 years	12 points
At least 6 years but less than 8 years	18 points
At least 8 years but less than 10 years	24 points
10 years or more	30 points

If you have satisfactory full-time deep sea experience while in possession of a valid license for Third Assistant Engineer, Motor Vessels, of at least 6000 H.P., or an appropriate higher level license (i.e, Second Assistant Engineer, or Chief Engineer) for: **You will receive up to:**

At least 2 years but less than 4 years	4 points
At least 4 years but less than 6 years	8 points
At least 6 years but less than 8 years	12 points
At least 8 years but less than 10 years	16 points
10 years or more	20 points

Each year of experience will be credited under only one category which will be the highest appropriate category.

During the Education and Experience Exam (EEE), you may answer questions about your experience. If your experience was on a part-time basis working less than 35 hours per week, you will need to convert your part-time experience to full-time experience using the formula below. Once you have determined your full-time experience equivalent, use this amount to answer questions about your experience.

$(\text{number of hours worked per week}/35) \times (\text{number of months worked})$

For example, if you worked at a job for 21 hours per week for 12 months, you would make the following calculation: $21/35 \times 12 = 7.2$ months.

You will receive a maximum of one year of experience credit for each year you worked.

You have until midnight Eastern time on the last day of the Application Period (August 30, 2022) to clearly specify in detail all of your relevant education and experience and Final Submit your Education and Experience Exam in the Online Application System (OASys). Once you Final Submit your Education and Experience Exam in OASys, you will not be permitted to submit new or additional information on your Education and Experience Exam online.

If you do not Final Submit your Education and Experience Exam in OASys by midnight Eastern time on the last day of the Application Period (August 30, 2022), your examination will be considered incomplete, you will not receive a score, you will not be invited to subsequent portions of this

examination (if applicable), and your application fee will not be refunded.

Experience must be obtained by the last day of the Application Period (August 30, 2022).

THE TEST RESULTS:

If you pass the Education and Experience Exam, your name will be placed in final score order on an eligible list, you will be given a list number and you will be notified by email of your test results. The eligible list determines the order by which candidates will be considered for appointment. If you meet all requirements and conditions, you will be considered for appointment if your name is reached on the eligible list. Once a list has been established, it will typically remain active for four years. If you believe that your test part was rated incorrectly, you may submit an appeal of your score to DCAS, Committee on Manifest Errors, through the Online Application System (OASys). Your appeal must give specific reasons why your score should be higher. Your appeal may result in a higher or lower rating.

To access the appeal portal of OASys, please log into your OASys account at www.nyc.gov/examsforjobs and use the following steps:

1. Navigate to the Dashboard for the Appeals tab.
2. Click the NEW APPEAL button to create and submit your appeal.
3. Select the exam from the Exam drop-down list, and
4. Select the exam part from the Exam Part drop-down list.
5. Select the reason for your appeal from the Appeal Reason drop-down list (if applicable).
6. Enter the details of your appeal by providing specific reasons why your score should be higher.

ADDITIONAL INFORMATION:

If you have the experience and/or certifications listed in one or more of the areas below, you may be considered for appointment to positions requiring this experience and/or certification through a process called Selective Certification. If you qualify for Selective Certification, you may be given preferred consideration for positions requiring this experience and/or certification. If you wish to apply for Selective Certification, follow the onscreen instructions when completing the Education and Experience Exam to indicate your interest in such Selective Certification and Final Submit it in the Online Application System (OASys). Your experience and/or certification will be checked by the appointing agency at the time of appointment.

Municipal Government Experience (MGE): At least one (1) year of satisfactory, full-time experience working within a municipal government in a similar position, which provides services for a city with over 1 million in population.

Sludge Vessel Experience (SLU): At least three (3) years of satisfactory, full-time experience working on a sludge vessel.

First Assistant Engineer License (FAE): At least three (3) years of satisfactory, full-time experience as a Marine Engineer on diesel powered boats and a valid license for First Engineer, Motor Vessels, of at least 6000 H.P., issued by the United States Coast Guard Marine Inspection Service.

Application Receipt:

You will be emailed a receipt immediately after you have applied for the examination. If you do not receive this receipt, check "Junk", "Trash", or "Spam" folders for the primary email linked to your Online Application System (OASys) account. If you are unable to locate the email, you can view a summary of the notification email to you on your OASys Dashboard, then Notifications. If you are still unable to find the email, please email DCAS via the Contact feature available in OASys with a description of the issue and include the exam number and your profile number located on your Profile page. While on your Profile page, check that the email addresses you provided are correct and/or updated.

Promotion Test: A promotion examination for this title is being held for eligible employees. The names appearing on the promotion list will be considered first in filling vacancies.

PENALTY FOR MISREPRESENTATION:

Any intentional misrepresentation on the application or examination may result in disqualification, even after appointment, and may result in criminal prosecution.

The General Examination Regulations of the Department of Citywide Administrative Services (DCAS) apply to this examination and are part of this Notice of Examination. They are posted at nyc.gov/dcas and copies are available at the DCAS Computer-based Testing & Applications Centers.
