# PUBLIC HEALTH SANITARIAN

## **General Statement of Duties and Responsibilities**

This class of positions encompasses training for and performing professional responsibilities involving inspections to assure compliance with pertinent laws, rules and regulations governing food and general environmental sanitation, safety and health. There are two assignment levels within this class of positions. All personnel perform related work. The following are typical assignments within this class of positions.

#### Assignment Level I

Under close supervision, is trained in and performs beginning level professional work in public health inspection and environmental sanitation such as the following:

#### **Examples of Typical Tasks**

Makes periodic inspections of food processing and manufacturing establishments, warehouses, and wholesale and retail food establishments to ensure a pure food supply and to enforce pertinent laws, rules and regulations.

Inspects business establishments, multiple dwellings, stores, schools, NYC correctional facilities, institutions, Fulton Fish Market, day camps, day care facilities, recreational and other areas for environmental hazards, defective plumbing, inadequate water supply, overflowing cesspools, condition of sewers, condition of gas heating equipment, animals not properly controlled or housed, lead poisoning danger, window guards, insect or rodent infestation, noxious odors, or other unsanitary or hazardous conditions.

## Assignment Level II (See Special Note)

Under supervision, makes inspections to assure compliance with pertinent laws, rules and regulations governing the areas of food and general environmental sanitation, safety and health.

## **Examples of Typical Tasks**

Makes periodic inspections of food processing and manufacturing establishments, warehouses, and wholesale and retail food establishments, to ensure a pure food supply and to enforce pertinent laws, rules and regulations.

Inspects business establishments, multiple dwellings, stores, schools, NYC correctional facilities, institutions, day care centers, day camps, Fulton Fish market, recreational and other areas for environmental hazards, defective plumbing, inadequate water supply, overflowing cesspools, conditions of sewers, condition of gas heating equipment, animals not properly controlled or housed, lead poisoning danger, window guards, insect or rodent infestation, noxious odors, or other unsanitary or hazardous conditions.

Instructs operators in establishments under permit or jurisdiction of the NYC Department of Health and Mental Hygiene in principles of sanitation, vermin control, and other areas of environmental health.

#### **Qualification Requirements**

- 1. A baccalaureate degree from an accredited college, including or supplemented by 30 semester credits in the physical and/or biological sciences, i.e., biology, botany, chemistry, geology, physics, physiology, and zoology; of which not more than 12 credit hours may be in the applied sciences, i.e., environmental technology, sanitation technology, medical technology, public health, infection control or food service; or
- 2. An associate degree from an accredited college, with 15 semester credits in the physical and/or biological sciences, of which not more than 6 credit hours may be in the applied sciences, and five years of experience as a public health technician assisting sanitarians and engineers in carrying out the various elements of prevention and control programs affecting the public's health.

# To be eligible for appointment to the title of Associate Public Health Sanitarian, candidates must have at least two years of experience as a public health sanitarian, as required by the Compilation of the Rules and Regulations of the State of New York (NYCRR) – Title 10 (Health) (Section 11.112).
