Prepares reports and orders and maintain records and inventories of supplies and materials.

Operates motor vehicles or equipment in the performance of assigned duties.

Qualification Requirements

- 1. Five years of full-time satisfactory experience as an auto mechanic specializing in automotive diesel engine repair work; or
- 2. Not less than two and one-half years of full-time satisfactory experience as an auto mechanic specializing in automotive diesel engine repair work plus sufficient helper or apprentice experience or relevant education acquired in a college, university, technical school, trade school or vocational high school to make up the equivalent of five years of acceptable experience. Six months of acceptable experience will be credited for each year of helper or apprentice experience or relevant education. Less than a full year of helper or apprentice experience, or relevant education will receive prorated credit.

License Requirements

At the time of appointment candidates must possess a New York State Class B Commercial Driver License ("CDL") or a Motor Vehicle Driver License valid in the State of New York and a Learner's Permit for a Class B Commercial Driver License. Appointees hired with a Learner's Permit must obtain the Class B CDL within six months of appointment. The CDL, with no restrictions must be maintained for the duration of employment.
