
ACQUISITION FOR ROADWAY IMPROVEMENTS IN RICHMOND VALLEY ROAD, S.I. DDC CAPITAL PROJECT ID: HWR005-12

The City of New York through its Department of Design and Construction (DDC), proposed to acquire the mapped right-of-way for roadway improvements in Richmond Valley Road from Page Avenue to Arthur Kill Road, Staten Island.

The properties to be acquired are shown below on the proposed Damage and Acquisition Map. No. 4268.

At the public hearing, DDC will outline the purpose, proposed locations and other information about the project. There will be an opportunity to provide comments on the record and for a limited period after the public hearing.

Upon the conclusion of the public hearing, DDC will be available to answer questions as to how the properties to be acquired are impacted.






