FY 2014 Q2 (Oct. - Dec. 2013)**

The Shelter Performance Report (SPR) measures shelter facilities' relative performance in three key categories: linking clients to public assistance and employment, length of stay in shelter, and housing placements. We appreciate our providers' tireless efforts in serving homeless families. Those efforts led to the placement of over 5,600 families with children into housing in the community in FY 2013. Below is a list of DHS' Families with Children shelters, grouped by performance tier and listed in alphabetical order. Please note that the shelters listed are only those which are contracted to provide their clients full social services. (Other types of shelters including hotels, cluster sites and Next Step facilities are not included on this list.)
