I. Responses to Requests for Clarification.

1. Note #1 in the Bid Sheet requires bidders to include prevailing wage and supplemental benefits which, at the time of this addendum, is currently \$105.86/hr for Electrician "A". Note #2 requires bidders to include labor, fringe benefits, statutory taxes, bidder's general liability, travel expenses, truck, tools and equipment expenses, plus overhead and profit. Some bidders claim to pay "fringe" benefits to the union and require clarification regarding Note #1 and #2.

The intent of the Contractor's Labor Mark-up or "Percentage Mark-Up" as defined in section 2.1.32 of Section V: Agreement is to allow the Contractor to include, without limitation, any and all elements of overhead and profit and all direct and indirect cost incurred by the Contractor. With the exception of parts and materials, and any other reimbursable expenses allowable in this Contract, the Contractor will not be reimbursed separately for any other costs associated with the required Work performed. Fringe benefits as indicated in Note #2 of the Bid Sheet imply other benefits that the Contractor may want to supplement its employees' wages or salaries in addition to the supplemental benefits required by Section 220 of the Labor Law.

2. Are performance and payment bonds required for the whole cost of the contract or for each individual Work Order?

The Contractor shall obtain performance and payment bond in the amount of 100% of the value of the Contract.
