

# 4,450 New Permits Over Next 10 Years

- Local law changes how vendors can get a full-term permit.
  - It now requires a new type of license called a supervisory license, of which there is a limited amount. There are 445 applications given out each year through 2032.
- The only way to get a full-term permit is to get a supervisory license first.
- Supervisory license permitted units must have a designated supervisory license holder while operating.
- These changes do not apply to green cart, temporary (seasonal) or restricted area permits.



# What Is a Supervisory License (SL)?

- Two types:
  - A citywide license
  - A license for all New York City boroughs except Manhattan (non-Manhattan)
- A supervisory license allows you to:
  - Vend on the same units as an MFV license holder.
  - Work as the designated SL vendor on a SL permitted unit in the area you have a license for.
  - Apply for one full-term permit for the area indicated on your license.
- There are three waiting lists: one for citywide, one for non-Manhattan and one list for disabled people and U.S. veterans.





#### Where Can You Work as a Supervisory License Holder?

- If you have a citywide supervisory license, you can work as the supervisory license holder on any supervisory license-permitted unit.
- If you have a non-Manhattan supervisory license, you can work as the supervisory license holder on any supervisory license-permitted unit outside of Manhattan.

If you work as the designated supervisory license holder outside of the geographical restrictions of your license, you can receive a violation that carries a penalty of \$1,000.





# **Supervisory License: How Is It Different?**

#### **MFV License**

No limit. Anyone can apply for this license.

Required for restricted, green cart, temporary permits, full-term permits issued before July 2022.

You can work on any permitted unit.

You can renew your license if it expires.

License term is two years.

The initial and renewal fees are \$50.

#### **Supervisory License**

Limited number. You must be on a waiting list.

Required for new full-term permits issued on and after July 2022.

You can work on any permitted unit as a vendor.

Cannot renew if it expires. You can return to an MFV license if it expires.

Initial expiration is the same as your current license. After renewal, license term is two years.

The initial fee is \$0, and the renewal fee is \$438.



# **Supervisory License Permit: How Is It Different?**

# Full-term permits before July 2022

Permit types: Citywide, borough-specific.

Applicant must have a MFV license, there is a limited time to apply.

Requires that all workers must have an MFV license.

### **Supervisory license permit**

Permit types: Citywide, non-Manhattan.

Applicant must have a supervisory license; there is <u>no</u> time limit to apply.

Requires a supervisory license holder to operate; other workers must have an MFV license or supervisory license.



#### Requirement for Supervisory License Permits: A Supervisory License Holder Must Be Working While Operating

- Operating in Manhattan only a citywide supervisory license holder can meet this requirement.
- Operating outside of Manhattan any supervisory license holder can meet this requirement.

The permit holder will receive a violation that carries a penalty of \$1,000 for operating without a supervisory license holder.





# How Do I Get a Supervisory License?

- 1. The NYC Department of Health and Mental Hygiene (Health Department) will mail you an application when your position number on a waiting list is reached.
- 2. You must have a current mobile food vending license.
  - If your mobile food vending license is close to its expiration date, renew it first, and then submit your application to avoid any additional fees.
- 3. You must submit a complete application, including any required proof, by the application deadline.

# **Full-term Supervisory License Permit**

- Once you receive your supervisory license, you will be able to apply for a full-term permit.
- You will be mailed a supervisory license permit application. There is no deadline to submit the application.
- Your unit requires at least one supervisory license holder and all vendors working must have either an MFV license or a supervisory license.



# I Have a Permit and I Received a Supervisory License Offer. Can I Have Both?

No. Each vendor can only get one permit, except restricted area permits.

- If you apply for a supervisory license, you have 270 days after your supervisory license is issued or until your current permit expires, whichever is sooner, to turn in your current permit.
- You must decide if you will apply for the supervisory license or keep your current permit.
  - Business factors to consider:
    - Where do you plan to vend?
    - What type of food will you sell?
    - What times of year do you plan to operate?
    - Do you plan to be the primary person working on the unit?



### What If You Do Not Get a Supervisory License?

- You keep your MFV license and can work on any permitted MFV unit (including a supervisory license-permitted unit, if a supervisory license holder is present).
- Your offer letter includes a date by which you must apply.
- If you miss the deadline, you will be removed from the supervisory license waiting list.
- You keep your current permit, if you have one.
- You remain on other permit waiting lists, if applicable.



# All Full-term Permits Will Require a Supervisory License in 2032

- For citywide or borough-specific permits issued before July 1, 2022, the permit holders' MFV license will convert to a supervisory license on July 1, 2032. These units will require a supervisory license holder be present while vending.
- The Health Department will issue rules on this requirement at a later date.



# Keep Your Contact Information up to Date
